6. The Clerk has duplicated the audio recording of the hearing(s), date(s) listed above, and shall deliver the duplicate recording, a copy of these Appellate Entries, and a copy of the order upon which this appeal is based to the person designated by the AOC Court Reporter Coordinator to produce a transcript of the hearing(s) pursuant to Appellate Rule 3.1. The person designated to produce the transcript of the hearing shall produce the transcript and shall comply with the conditions specified by the Court in the Clerk's Transcript Order and Certificate. No fee shall be charged for the cost of the duplicate recording.
