## NOTE TO VICTIM OR PERSON ASSERTING RIGHTS ON BEHALF OF VICTIM

**NOTE:** A victim may assert the rights under Article 46 ("Crime Victims' Rights Act") of Chapter 15A by filing a motion within the same criminal proceeding that gave rise to the rights of the victim. Any of the following persons may file the motion:

- the victim; the victim's attorney; the prosecutor, at the request of the victim;
- a parent, guardian, or legal custodian of the victim, if the victim is a minor or is legally incapacitated;
- a spouse, child, parent, guardian, legal custodian, sibling, or grandparent of the victim (in that order of priority, with the victim's spouse having first priority), if the victim is deceased. (If the deceased victim was a minor, then the guardian or legal custodian of the minor has priority over any other family member.)

The defendant may **not** assert the rights of the victim. An individual who has first priority to exercise the victim's rights as a family member (spouse, child, parent, guardian, legal custodian, sibling, or grandparent) may designate another family member to act on behalf of the victim. A victim has the right to consult with an attorney regarding an alleged violation of the Crime Victims' Rights Act, but a victim does not have a right to counsel provided at State expense. If the judge fails to review the motion and dispose of it or set it for hearing in a timely manner, the victim may petition the NC Court of Appeals for a writ of mandamus as provided in G.S. 15A-834.5(h).
