For supervised probationers, parolees, and post-release supervisees discharged from supervision and inmates released from active sentences for North Carolina convictions, a certificate of restoration is issued by the supervising or custodial agency. CERTIFICATE OF RESTORATION

The person named above is a resident of the county named above and was convicted of a crime against the United States or another state whereby his/her citizenship rights were forfeited. Pursuant to G.S. 13-2(b), that person has presented to the undersigned a paper writing from the agency of the other state or of the United States which had jurisdiction over the person, stating that on the Date Of Discharge for the conviction shown below, the person named above was:

1. discharged unconditionally by that agency.
2. pardoned by the President of the United States or the Governor of the state in which the person was convicted, and that his/her pardon was:
- a. unconditional.
- b. conditional, and the person has satisfied the conditions of the pardon.

Pursuant to G.S. 13-1, the person's citizenship rights forfeited as a result of the case/conviction below have automatically been restored.

NOTE TO RESTORED CITIZEN

This certificate evidences the restoration of some, but not all, of the rights forfeited as the result of your conviction in the case listed above. This restoration applies only to rights forfeited as a result of the specific case listed; it does not restore rights still forfeited as a result of other convictions.

If you have no other convictions for which your rights were forfeited, this Order does restore your rights to vote, to serve on a jury, and to run for or hold most (but not all) elected or appointed offices in the State. To vote, you must first register with your local board of elections. Information on registering to vote is available online at www.ncsbe.gov.

Unless specifically restored by the laws or agency of the other state or of the United States, this certificate does not:

- expunge, reverse, or conceal the record of conviction in the case listed above;
- restore the right to possess a firearm;
- restore a drivers license or other government-issued license that may have been revoked or suspended as a result of your conviction;
- remove other consequences of conviction, like registration as a sex offender or a court's finding of domestic violence offender status;
- satisfy outstanding civil obligations arising from the criminal case, like attorney fees, restitution, or forfeitures;
- prevent some licensing agencies or employers from considering your conviction in licensing or employment decisions; or
- restore other rights or privileges not specifically excluded here.

Questions about the rights that are or are not restored by this certificate should be directed to an attorney or to the government agency with authority over the right or benefit in question (e.g., the local board of elections). **The clerk of superior court cannot give you legal advice about rights that are or are not restored as a result of your discharge by the other state or federal agency.**
