Your request for hearing must be filed with the Clerk of Superior Court within twenty (20) days after the date of mailing or personal service of this notice.

Failure to contest the validity or enforcement of the registered Foreign Support Order(s) in a timely manner will result in confirmation of the order(s) and the enforcement of the order(s) and the alleged arrearages.

If you want to contest the validity of a registered Convention support order, as defined by G.S. 52C-7-701(3), and you reside in the United States, you must file a written request for a hearing no later than thirty (30) days after the date of mailing or personal service of this notice. If you do not reside in the United States, you may file your request no later than sixty (60) days after the mailing or personal service of this notice.
