**REVOCATION ORDER FOR PROVISIONAL LICENSE

The undersigned judicial official conducting an initial appearance in this case finds probable cause to believe that:

1. A law enforcement officer had reasonable grounds to believe that the above named person committed a criminal moving violation as defined in G.S. 20-13.3(a)(2).
2. The above named person has been charged with that offense.
3. The above named person is a provisional licensee under age 18 as defined in G.S. 20-13.3(a)(4).
4. The above named person is **not** subject to a civil revocation pursuant to G.S. 20-16.5.

ORDER

1. It is ORDERED that the above named person's **limited learner's permit, limited provisional license, or full provisional license issued pursuant to G.S. 20-11 be revoked**, and the above named person is prohibited from operating a motor vehicle on the highways of North Carolina during the period of revocation.
2. The revocation remains in effect for at least **thirty (30) days** as shown in No. 4 below.
3. The beginning date of the revocation is the date of this Order, set out below.
4. The ending date of the revocation is (calculate per NOTE below) _____. The above named person's limited learner's permit, limited provisional license, or full provisional license will again be valid at 12:01 a.m. on this ending date unless the person's privilege to drive has been revoked by the court or the NC DMV for another reason.
(NOTE: Pursuant to G.S. 1A-1, Rule 6(a), when computing the thirty (30) days, do not include the day of this Order, but do include the thirtieth (30th) day. If the thirtieth (30th) day falls on a Saturday, a Sunday, or a legal holiday when the courthouse is closed for transactions, the revocation remains in effect until the next day when the courthouse is open for transactions.)

CERTIFICATION OF JUDICIAL OFFICIAL

I have given the above named person a copy of this Order, which includes the beginning date of the revocation and clearly states the final day of the revocation period on which the permit or license of the person named above again becomes valid. I also have personally informed the above named person that he or she has a right to a hearing to challenge this revocation order under G.S. 20-13.3(d2), and that his or her permit or license will remain revoked pending any challenge hearing.

1. You are not required to surrender to the court your limited learner's permit, limited provisional license, or full provisional license. However, the court will report this revocation to the North Carolina Division of Motor Vehicles (NC DMV) and **YOU ARE NOT AUTHORIZED TO DRIVE AT ANY TIME OR FOR ANY PURPOSE DURING THE PERIOD OF THIS REVOCATION.**
2. You are not eligible to receive a limited driving privilege during the period of this revocation.
3. Your limited learner's permit, limited provisional license, or full provisional license will again be valid at 12:01 a.m. on the "ending date" shown in Order Item No. 4 above, unless your privilege to drive has been revoked by the court or the NC DMV for another reason. If you have any questions about your authorization to operate a motor vehicle, you should consult an attorney licensed to practice law in North Carolina, or the NC DMV.
4. You have a right to a hearing to challenge this Order before a magistrate or a judge under G.S. 20-13.3(d2). The form to request this hearing is AOC-CVR-16. You must file this request within ten (10) days of the "beginning date" as shown in Order Item No. 3 above. Your limited learner's permit, limited provisional license, or full provisional license will remain revoked pending the challenge hearing. If you request a hearing, but fail to appear at the hearing, you forfeit your right to a hearing.
5. **IT IS UNLAWFUL FOR YOU TO DRIVE A MOTOR VEHICLE IN THE STATE OF NORTH CAROLINA UNTIL YOU ARE ONCE AGAIN AUTHORIZED TO DO SO.**
