APPOINTMENT OF PROVISIONAL COUNSEL

It appearing to the Court that the respondent parent named above is party to a proceeding in which there is now filed a motion for a modification hearing under G.S. 7B-1000, and that the respondent parent was previously appointed counsel under G.S. 7B-602 and that said counsel was released, it is determined by the Court that G.S. 7B-1000(d) dictates that the respondent parent shall now be appointed provisional counsel; it is ORDERED that the respondent parent is entitled to the services of provisional counsel as contemplated by law.

NOTE: Pursuant to G.S. 7B-602(a), at the next hearing the court will either dismiss the provisional counsel or confirm the appointment of counsel. Form AOC-J-144 (Order Of Assignment Or Denial Of Counsel) may be used by the court for that purpose.

NOTICE TO PARENTS ABOUT APPOINTED PROVISIONAL COUNSEL

You have a right to be represented by a lawyer at all stages of the proceeding. If you want a lawyer and cannot afford to hire one, the Court will appoint a lawyer to represent you. You may hire a lawyer of your choice at any time, or you may waive the right to a lawyer and represent yourself.

If you want a court-appointed lawyer, you are encouraged to immediately contact the following lawyer who has been temporarily assigned to represent you. At the next hearing, the Court will determine whether you qualify for a court-appointed lawyer. If you do not qualify, the lawyer named below will be released.
