Further, that the Clerk mail a copy of this Order to the area mental health director

- 4. **In-Home Supervision With Conditions** [G.S. 7B-2503(1)(a)]. The juvenile remain at home and be supervised by \_\_\_\_\_, subject to the following conditions applicable to the parent, guardian, custodian, and/or the juvenile, as specified:
