## 1. Revision to docketing Plan-Plea Rejection Form

The criminal docketing plan for 19-B is modified pursuant to a separate order effective with the August, 2009 term of Administrative Court. Each defendant who receives a plea offer before the first setting in administrative court shall accept or reject the plea offer no later than the second administrative setting. The rejection of the plea offer shall henceforth be memorialized by execution of the plea rejection form order attached to the memorandum. The administrative order allows for instances where no plea is made prior to the first session of administrative court or where the plea offer is modified by the District Attorney and does not restrict the ability of the District Attorney to offer a plea at any time.

#### 2. Requirements for entry of Ex-Parte Orders

All Motions for Ex-Parte Orders shall henceforth set out in bold print whether the case is set for trial and if so the trial date, the information shall also be included in bold print in the proposed Ex-Parte Order.

# ADDENDUM SUPERIOR CRIMINAL COURT DOCKETING PLAN FOR JUDICIAL DISTRICT 19B EFFECTIVE AUGUST 11, 2009

This addendum to the Superior Criminal Court docketing plan for Judicial District 19B shall be effective beginning August 11, 2009. To the extent this addendum conflicts with the previous docketing plan for Judicial District 19-B, this addendum shall be the controlling authority.

Beginning August 11, 2009 all defendants in superior criminal court who reject a plea offer shall execute the plea rejection notice attached. If the initial plea offer is made to the defendant prior to the first administrative court setting, then the plea rejection notice shall be executed by the defendant and counsel no later than the second administrative court setting and filed with the District Attorney's Office. If the initial plea offer is made after the first administrative court setting then the defendant shall have an additional administrative setting to accept the initial plea or file the plea rejection notice with the District Attorney's Office.

If the initial plea is rejected and the State modifies the plea, the defendant shall have an additional setting in administrative court to accept the modified plea or file the plea rejection notice with the District Attorney's Office no later than the next administrative court setting. This order does not limit the discretion of the District Attorney to offer a plea at any time during the proceedings or to decline to make a plea offer.

The State shall inform the presiding judge at trial prior to proceeding if the plea rejection notice was not executed and filed.
