**ORDER ON APPEAL FROM DENIAL OF
HANDGUN
RECEIPT/PURCHASE PERMIT**

G.S. 14-404(b)

This matter came before the undersigned Chief District Court Judge on an appeal from the Sheriff's denial of a permit for the receipt or purchase of a handgun under Article 52A of Chapter 14 of the General Statutes. Following a hearing at which the Court considered the facts, the law and the reasonableness of the Sheriff's refusal, the Court makes the following findings of fact and conclusions of law:

FINDINGS OF FACT
