ORDER ON APPEAL FROM
 DENIAL REVOCATION NONRENEWAL
OF A CONCEALED HANDGUN PERMIT
G.S. §14-415.15(c), §14-415.18(a), and §14-415.18(a1)

This matter came before the undersigned District Court Judge on an appeal from the Sheriff's denial, revocation or nonrenewal of a concealed handgun permit under Article 54B of Chapter 14 of the General Statutes.
