A scheduling Calendar Conference has been set at the Wilson County Courthouse, 115 Nash Street, Wilson, NC 27893, in the Superior Courtroom (3rd floor) @ 2pm. The Edgecombe County Conference will be held at the Courthouse @ 11am, in the Law Library if court is in session OR at the Wilson County Courthouse @ 11am if “Out of Session” is indicated on the calendar.

A calendar of pending cases, a schedule of Wilson & Edgecombe County Civil sessions for SPRING and/or FALL and a Civil Case Status Report form may be found as an attachment **(Attachment A)**. If your case currently has a trial date, I strongly encourage you to attempt to settle your case before your trial date. If your case has a trial date in the (SPRING) May/June or (FALL) November/December and you are certain that your case will not be ready for trial, please indicate that under the “Comments” section on the status report form. It is very important that you inform the court in advance if you know your case will not be ready for trial and you wish to request a continuance. In addition, if your case is closed or has been removed to another court, please provide details regarding the disposition of your case under the “Comments” section on the status report form.

The presence of counsel at the conference is not required. If counsel cannot be present, he or she should confer with opposing counsel and return a report of the status of the case to the Court Manager by email attachment in PDF format to: Kimberley.J.Hines@nccourts.org or by mail to Kimberley J. Hines, Court Manager, II, P.O. Box 2445, Wilson NC 27894-2445 by **10-DAYS PRIOR TO THE SESSION**. It will be necessary to confer as the report shall be signed by counsel for all parties.

Those who choose not to attend nor submit a report will have their case set for trial on a date determined by the Senior Resident Judge. Please note that the court will try to accommodate the date for which counsel makes a timely request; however, it is not possible to accommodate every request. Therefore, it is the responsibility of counsel to check the www.nccourts.gov website to confirm the date of his or her case that is listed on the scheduling calendar.
