ADMINISTRATIVE ORDER COVID-19 EMERGENCY HEALTH CRISIS MAY AND JUNE 2020 COURT OPERATIONS

NOW COMES the undersigned Senior Resident Superior Court Judge and enters this Administrative Order concerning Court operations for May and June of 2020.

IT APPEARING TO THE COURT that the Chief Justice has declared that catastrophic conditions exist in all North Carolina counties. Although the Superior Court will remain open for business, the normal operation of the court will change to contain emergency directives to reduce the spread of infection.

This Administrative Order is in addition to all previous Orders.

NEW PROCEDURES

In order to expand the use of Court time, and to handle non-custody matters, the two following procedures are adopted.

1. Hearing of non-custody defendant pleas, motions and probation violations.

During the month of May and June, non-custody defendant pleas, motions and probation violations may be taken pursuant to the following rules:

a.) Plea transcripts must be signed by all parties prior to scheduling, however they may be modified if necessary.

- b.) Each attorney having non-custody pleas, motions or probation violations shall notify the District Attorney in advance of the session. The parties shall consult and such attorney shall be allocated a designated time period, and a specific time for each defendant to appear in the courtroom, which shall not overlap.
- c.) Essential victim rights witnesses and defense witnesses who are to address the Court shall be allowed to appear. No other attorney, defendant or witness not necessary for the plea or probation violation shall remain in the courtroom. All persons present shall at all times sit on alternate rows of the courtroom, at least 6 feet apart.
- d.) All persons present in the courtroom are encouraged to wear gloves and a mask as appropriate.

2. Specific rules for Grand Jury sessions until further notice:

- a.) The Grand Jury will meet in an empty courtroom, meeting room, or the actual courtroom itself, that is large enough to accommodate the 18 Grand Jurors, and the witness appearing before them. All Grand Jurors shall be seated at least 6 feet apart.
- b.) Each Grand Juror shall be provided a mask and gloves, and sanitizer shall be on site, for their use if desired.
- c.) All witnesses appearing before the Grand Jury shall wear a mask and gloves.
- d.) Breaks to include hand washing shall be taken as needed.
