Why am I receiving this notice? Your case has custody or visitation issues pending before the Court, which requires participation in our mandatory Custody Mediation Program.

What happens during the Orientation/Class? Parties receive information about custody mediation and the impact of parental conflict on children. The Orientation/Class will take up to TWO HOURS to complete. The Orientation/Class is typically held in a group setting but is offered to Spanish-speaking parties in a selfdirected format. If you are fluent in both languages and wish to attend the live online English version instead of the Spanish self-directed version, please contact (919) 808-3025.

What happens after the Orientation/Class? A mandatory private Mediation Session occurs after all parties complete Orientation/Class. Private Mediation Sessions are being held by video conference until further notice.

What is the purpose of Mediation? Mediation is a practical way to resolve custody and/or visitation matter(s) quickly and at no cost. Parties have an opportunity to create a workable parenting plan with the assistance of a neutral, professional mediator. The goal is to bring parties together regarding the best interests of the child(ren) and avoid having decisions made by a judge. Agreements reached in mediation become a binding and enforceable Order of the Court once signed by the Presiding District Court Judge.

What if I received this Notice the completion deadline/date? Please complete the tasks as noticed here, even if you receive the notice after the deadline and/or contact the Mediation Office at (919) 808-3025.

What if I have safety concerns or an order of protection? Please contact either (919) 808-3025 or (919) 808-3225 to discuss safety concerns and/or protective orders as they relate to mediation. If there is an existing Protective Order, please indicate this on your Mediation Intake Form and/or contact the Custody Mediation Office. Some cases may qualify for a waiver of mediation.

Am I required to complete this Orientation/Class? Is the requirement ever waived? Mediation is required for all cases unless it is waived by the Court due to qualifying specific circumstances. If you wish to seek a waiver of mediation, you may choose to file a *Motion and Order to Waive Custody Mediation* (FORM AOC-CV-632), which can be found at <u>www.nccourts.gov</u> or obtained in the Family Court Suite (Suite 6500).
