**CONSENT
CASE MANAGEMENT ORDER**

Pursuant to 10th Judicial District Local Rules for civil Superior Court, this Case Management Order is entered by the undersigned Trial Court Administrator at the direction of, and with the permission of, the Honorable Paul C. Ridgeway, Senior Resident Superior Court Judge.

Pursuant to N.C. Gen. Stat. § 1A-1, Rule 16, and by and with the consent of the parties, this Consent Case Management Order shall govern discovery and trial of this case. Except where modified by this Order, the Local Rules for Civil Superior Court Tenth Judicial District are incorporated into this Order. This Order supersedes any previous Case Management Orders entered in this case and is subject to further amendment upon motion for good cause shown, or by the Court, made with the Trial Court Administrator under Local Rule 4. Requests to modify the trial date must be made by filing a motion to continue pursuant to Local Rule 8.

1. **Trial Date.** Trial date for this matter must be within twelve (12) months of the filing date, _____ . This case is hereby set for trial to begin on _____ .
2. **Length of Trial.** Estimated length for a Jury Trial / Non-Jury Trial is _____ days.
3. **Order to Mediation and Mediation Deadline.** This Consent Case Management Order shall also serve as the *Order to Mediated Settlement Conference*. * The deadline for the mediated settlement conference shall be **60 days prior to the trial date**, pursuant to Local Rule 15.3, unless otherwise set by court order.

**A mediator selected by agreement of the parties shall be compensated at a rate agreed upon between the mediator and the parties. A court-appointed mediator shall be compensated at the rate of \$150/hour for time spent in the mediation, to be billed in quarter hour segments. See MSC Rule 7.*

4. **Designation of Mediator.** The parties hereby select _____ as the mediator in this action. This designation is submitted in lieu of filing the *Designation of Mediator* form (AOC-CV-812), as required by Local Civil Rule 15.4. The parties must notify the selected mediator by sending a copy of this Order to him/her.

5. **Discovery.** The deadline for discovery shall be **60 days prior to the trial date**, unless otherwise set by court order. Expert witness discovery shall comply with amended N.C.G.S. 1A-1, Rule 26(b)(4) for all actions commenced on or after October 1, 2015.

6. **Dispositive Motions.** Dispositive motions must be calendared, in accordance with Local Rules, so that they are **heard no later than 30 days prior to the trial date**, unless otherwise set by court order.
