## ORDER ON DESIGNATION

- 1. **THIS MATTER** is before the Court pursuant to the Determination Order filed on 12 August 2025 by the Honorable Paul Newby, Chief Justice of the Supreme Court of North Carolina, directing the undersigned to determine whether this action is properly designated as a mandatory complex business case in accord with N.C.G.S. § 7A-45.4(a).
- 2. On 18 June 2025, Plaintiffs Sugarbranch Development, LLC, Sugartree Issuer, LLC, Sugartree Class A, LLC, Sugartree Manager, LLC, Brett N. Ermer, Cynthia Rose Linn, and Michael A. Goddard initiated this action upon the filing of the Complaint in Mecklenburg County Superior Court. (See Compl., ECF No. 2.) According to the Notice of Designation (NOD), Defendants Burbank Financial Partners, LLC, Burbank Management Partners, LLC, Burbank Private Equity

Group, LLC, and Rodney Wilson, (a/k/a Rodney E. Wilson, Jr.) (Defendants) were served with the Complaint on 24 June 2025. (Notice Designation 3, ECF No. 3 [NOD].)

- 3. On 24 July 2025, Defendants filed their NOD with the Mecklenburg County Clerk of Superior Court. (NOD 1.) However, Defendants did not contemporaneously serve the NOD on the Chief Justice of the Supreme Court of North Carolina and the undersigned Chief Judge of the North Carolina Business Court as required by N.C.G.S. § 7A-45.4(c). To date, neither the Chief Justice nor the undersigned have received service of the NOD.<sup>1</sup>
  - 4. Pursuant to N.C.G.S. § 7A-45.4(c),

A party designating an action as a mandatory complex business case shall file a Notice of Designation in the Superior Court in which the action has been filed, shall contemporaneously serve the notice on each opposing party or counsel and on the Special Superior Court Judge for Complex Business Cases who is then the Chief Business Court Judge, and shall contemporaneously send a copy of the notice by e-mail to the Chief Justice of the Supreme Court for approval of the designation of the action as a mandatory complex business case.

(Emphasis added).

5. The Business Court provides explicit instructions on its website as to how to properly effectuate service under the statute.<sup>2</sup> The contemporaneous filing and service requirement set forth in N.C.G.S. § 7A-45.4(c) is mandatory, and Defendants' failure to comply with that requirement renders the NOD untimely.

6. Based on the foregoing, the Court concludes that this action shall not

proceed as a mandatory complex business case under N.C.G.S. § 7A-45.4(a) and thus

shall not be assigned to a Special Superior Court Judge for Complex Business Cases.

7. Consistent with the Determination Order, the Court hereby advises the

Senior Resident Superior Court Judge of Judicial District 26 that this action is not

properly designated as a mandatory complex business case so that the action may be

treated as any other civil action, wherein designation as a Rule 2.1 exceptional case

may be pursued with the Senior Resident Superior Court Judge if deemed

appropriate.

8. The Court's ruling is without prejudice to the right of the parties to

otherwise seek designation of this matter as a mandatory complex business case as

may be permitted under N.C.G.S. § 7A-45.4.
