The mission of the North Carolina Administrative Office of the Courts is to provide services to help North Carolina's unified court system operate more efficiently and effectively, taking into account each courthouse's diverse needs, caseloads, and available resources.

Introduction

N.C.G.S. 7A-109(d) provides as follows:

(d) In order to facilitate public access to the electronic data processing records or any compilation of electronic court records or data of the clerks of superior court, except where public access is prohibited by law, the Director may enter into one or more nonexclusive contracts under reasonable cost recovery terms with third parties to provide remote electronic access to the electronic data processing records or any compilation of electronic court records or data of the clerks of superior court by the public. Neither the Director nor the Administrative Office of the Courts is the custodian of the records of the clerks of superior court or of the electronic data processing records or any compilation of electronic court records or data of the clerks of superior court. Costs recovered pursuant to this subsection shall be remitted to the State Treasurer to be held in the Court Information Technology Fund established in G.S. 7A-343.2.

Section (e) of the statute requires the North Carolina Administrative Office of the Courts (NCAOC) to report on any contracts entered into under G.S. 7A-109(d) in effect during the calendar year. NCAOC respectfully submits this report pursuant to the legislative mandate.

Types of Access

NCAOC offers two basic types of contractual access – remote public access and batch extract access. Remote public access clients receive real-time remote access to NCAOC’s criminal and civil databases, while batch extract clients receive daily updates of data from NCAOC’s criminal and civil records databases. Those databases include Calendar Offense (CalnOffn), New Case (New Case), Demographic (DEMO), Evictions (EVT), and Federal Tax Liens (Tax Liens).

North Carolina governmental agencies that share information with NCAOC or enter data into NCAOC’s systems have free online access to NCAOC’s databases. North Carolina governmental agencies that do not share information with NCAOC pay a one-time fee for online access to NCAOC’s systems.

The attached Appendix provides a listing of all licensees that had licensing agreements for remote public access or batch extract access at any time during the 2021 calendar year. The Appendix also includes a listing of government entities who license remote public access, but do not share data with NCAOC.

Summary

NCAOC provides remote access to public records pursuant to G.S. 7A-109 in accordance with the legislative mandate. This report provides a listing of all licensees for whom NCAOC provided electronic access to public records during calendar year 2021.
