

EXECUTIVE SUMMARY

This report presents an analysis of sentences imposed on misdemeanor offenders under Structured Sentencing during the first six months of 1995. Issues explored in this monitoring report include the number of convictions by month, offense class and prior conviction level, demographic characteristics of offenders, types of punishments imposed and average minimum sentences, types of Intermediate Punishments imposed and hours of community service imposed. Preliminary data reveal several important findings:

- During this reporting period, 57,772 misdemeanor offenders were convicted under Structured Sentencing.
- Offenders convicted of a Class 1 Misdemeanor Offense and classified in Prior Conviction Level I accounted for the greatest number of convictions.
- Demographic data reveals that about 81% of all misdemeanor offenders were male; more than half were under the age of 30; and approximately 49% were Black and 42% were White.
- About 15% of all misdemeanor offenders received Active Punishments; about 5% received Intermediate Punishments; and about 80% received Community Punishments.
- Active Jail sentences were most frequently imposed on offenders convicted of a Class 3 Misdemeanor Offense and classified in Prior Conviction Level III.
- Property Offenses accounted for the highest percentage of offenders receiving an Active Punishment. Drug Offenses accounted for the lowest percentage of offenders receiving an Active Punishment but accounted for the highest percentage of offenders receiving a Community Punishment.
- Of the seven types of Intermediate Punishment, Special Probation was the most frequently invoked punishment. Offenders convicted of a Class 1 Misdemeanor Offense and classified in Prior Conviction Level II were most likely to receive Special Probation as an Intermediate Punishment
- Of all misdemeanor offenders receiving community service, those convicted of a Property Offense were sentenced most frequently to community service. However, of offenders receiving community service, the most community service hours, on average, were ordered for those convicted of a Person Offense.

INTRODUCTION

This report covers misdemeanor offenders sentences under Structured Sentencing during the first half of 1995 (from January 1 through June 30). The report only covers cases where an offender was convicted and sentenced for a misdemeanor crime which was committed on or after October 1, 1994 (the effective date of Structured Sentencing).

The information contained in this report is based on data entered into the AOC Criminal Information System by the court clerk following the imposition of the sentence. Currently, this report covers all North Carolina counties except Mecklenburg. Information for Mecklenburg County will be included in later reports.

This report reflects the number of <u>offenders</u> sentenced, not the number of <u>offenses</u> sentenced. If a single offender was sentenced for more than one offense during a single session of court, only the most serious offense (the one with the highest Offense Class) and the most severe sentence imposed are included in this report.

<u>IMPORTANT NOTE:</u> Caution is strongly advised about drawing conclusions from the data included in this report. During the reporting period the system was in a learning and adjustment phase with the previous method of sentencing misdemeanants and the Structured Sentencing Act operating side by side. Consequently, short term sentencing patterns observed during this transitional period may not be indicative of future long term sentencing trends.


I. REPORTING OF SENTENCES

This section details the number of offenders sentenced for misdemeanor crimes under Structured Sentencing during the first half of 1995. It should be noted that misdemeanor Driving While Impaired offenses are not covered under Structured Sentencing. In addition, this report includes only those cases disposed of in superior or district court, not by magistrate. Finally, of all criminal traffic offenses, only Class 1 offenses are reflected in this report.

Overall, 57,772 offenders were reported. All of these offenders are included in this section (except for *Table 3*) and also in **Section II**. However, in later sections, information on 3,198 offenders was eliminated due to problems and errors with the data reported. Efforts continue to correct for these errors and to resolve initial reporting problems.

A. Convictions by Month

Figure A shows the number of offenders convicted under Structured Sentencing for the first six months of 1995. Further breakdowns of convictions by demographic variables are included in Appendix A.¹



B. Convictions by County and Judicial Division and District

Table 1 displays the number of offenders convicted in each county and Table 2 shows the number of offenders convicted in each judicial division and district (excluding Mecklenburg County). See Appendix B for a map of judicial divisions and districts.

These tables also show whether the conviction resulted from a guilty plea or jury trial. As expected, the vast majority (about 99.9%) of total misdemeanor convictions resulted from a guilty plea.

C. Convictions by Offense Class and Prior Conviction Level

Table 3 shows the distribution of convictions by Misdemeanor Offense Class and Prior Conviction Level. The greatest number of convictions fell into Offense Class 1 and into Prior Conviction Level I. Convictions containing incorrect Offense Classes, Prior Conviction Levels, or other errors were excluded from this table.


II. CHARACTERISTICS OF OFFENDERS

This section provides a breakdown of offenders by gender, race and age. Additional breakdowns of offenders by demographic characteristics are included in *Appendix A*.

Table4summarizesdemographiccharacteristics(gender, race and age) of allmisdemeanor offenders.

A. Convictions by Gender

Figure B shows that the majority of misdemeanor offenders were male (81%).



B. Convictions by Age

Figure C shows that more than half of all misdemeanor offenders were under the age of 30 (56.7%). Offenders under 21 years of age accounted for about 25% of the total number of misdemeanor offenders. Nearly 15% of all offenders were 40 years of age or older.






Figure D displays the age distribution of misdemeanor offenders. The volume of offenders peaks in the late teens and early twenties and then declines as age increases. It should be noted that data for age was missing for approximately 4,000 offenders.





C. Convictions by Race

Figure E shows that 49.4% of misdemeanor offenders were Black and 41.5% were White. Only a small percentage of offenders were Indian (1.8%), Hispanic (0.6%) or Unknown (6.6%).²


III. THE PUNISHMENT IMPOSED

This section details the type of punishment imposed (Active Punishment, Intermediate Punishment, or Community Punishment). It also shows the average minimum sentence imposed and the average actual time served for those offenders who received an Active Punishment. Additional breakdowns of punishments by demographic characteristics are shown in *Appendix A*. This section excludes convictions with reporting errors. In an effort to provide information to local and state ommunity corrections agencies, a distinction has been made between misdemeanor offenders who received sentences of 90 days or less and those who received sentences greater than 90 days.³

A. Overall Punishment

Figure F shows that approximately 15% of all misdemeanor offenders received Active Punishments, about 5% received Intermediate Punishments, and about 80% received Community Punishments.

Figure G shows that about 84% of all offenders receiving an Active Punishment received a sentence of 90 days or less. Approximately 16% of all offenders receiving an Active Punishment received a sentence greater than 90 days.




B. Type of Punishment by Offense Class

Table 5 shows the type of punishment received by Misdemeanor Offense Class. Table 5a and Table 5b indicate the type of punishment received by Misdemeanor Offense Class for those offenders sentenced to 90 days or less and those who received sentences greater than 90 days, respectively.

For all misdemeanors, *Table 5* shows that most offenders,

regardless of Offense Class, received Community Punishments. As expected, the greatest percentage (16.6%) of offenders receiving an Active Punishment fell in Misdemeanor Offense Class 1. However, Table 5a (representing those offenders who received sentences of 90 days or less) shows that a slightly



higher percentage of offenders in Misdemeanor Offense Class 3 (15.1%) received an Active Punishment than those in Misdemeanor Offense Class 1 (14.3%).

The tables also show the average minimum sentence imposed and the average actual time served by Offense Class for those offenders who received an active sentence. As *Tables 5* and *5a* indicate, the average minimum sentence imposed and the average actual time served increases as the Offense Class increases.

C. Type of Punishment by Offense Class and Prior Conviction Level

Table 6 shows the type of punishment received by Misdemeanor Offense Class and Prior Conviction Level. The table also displays the average minimum sentence imposed and average actual time served for each combination of Offense Class and Prior Conviction Level. In addition, Active Punishment is divided into Active Jail (offenders receiving a sentence of 90 days or less) and Active Prison (offenders receiving a sentence greater than 90 days) to further describe offenders.

The table indicates that as Prior Conviction Level increases, regardless of Offense Class, the percentage of offenders receiving Active Jail Punishment increases. Offenders convicted of a Class 3 misdemeanor and classified in Prior Conviction Level III were most likely to receive an Active Jail sentence (55.5%). As expected, offenders convicted of Class 1 offenses and classified in Prior Conviction Level III were the only offenders falling in the Active Prison category. However, the reader should note that this data reflect only the most serious offenses and may receive consecutive sentences which are not considered in this table. Thus, the data displayed in this table may underestimate the actual number of offenders who received an Active Prison sentence.

Concerning the average minimum sentence imposed and the average actual time served, *Table 6* indicates that for each Misdemeanor Offense Class, the average minimum sentence imposed and the average actual time served increases as Prior Conviction Level increases.

D. Type of Punishment by Crime Category

Table 7 shows the type of punishment received by crime category for all misdemeanors. Table 7a refers to those offenders receiving sentences of 90 days or less. Table 7b refers to those offenders who received sentences greater than 90 days. These tables also indicate average minimum sentence imposed and the average actual time served for offenders who received an Active Punishment.

All three tables indicate that, of the four types of crime, Property Offenses accounted for the highest percentage of offenders receiving an Active Punishment. For all misdemeanors, Property Offenses accounted for 18% of the offenders receiving an Active Punishment. Drug Offenses accounted for the lowest percentage (12.3%) of offenders receiving an Active Punishment but accounted for the highest percentage (83.2%) of offenders receiving a Community Punishment.

Tables 7 and 7a indicate that the average minimum sentence imposed and the average actual time served was longest for offenders convicted of Person Offenses. Table 7b shows that the average minimum sentence imposed and the average actual time served was longest for offenders convicted of Drug Offenses.

E. Consecutive Sentences

An assumption has been made throughout this report that all offenders convicted of multiple offenses received concurrent or consolidated sentences. This section attempts to estimate the impact of consecutive sentences on average minimum sentences. However, the database did not consistently identify consecutive sentences during this reporting period. Available data indicate that 37% of all active sentences were identified as either concurrent or Of these, 3% were consecutive. specifically coded as consecutive sentences. For the remainder, it was not clear whether the sentences were concurrent or consecutive.

Table 8 illustrates three different scenarios to help estimate the possible impact of consecutive sentencing on average minimum sentences. Tables 8a and 8b present these scenarios based on sentence length.

Column (1) assumes that all the above offenders received concurrent sentences: Column (2) assumes that all the above offenders received concurrent sentences except for those specifically coded as receiving consecutive sentences; and, Column (3) assumes that all the above received consecutive offenders sentences. In essence, these three scenarios give a range of possibilities for the average minimum sentence imposed -- Column (2) shows the minimum possible impact of consecutive sentences and Column (3) shows the maximum possible impact of consecutive sentences. For example, for Class 1 Misdemeanor Offenses, offenders ordered to serve consecutive sentences receive at least an average of 1.8 additional days and not more than an average of 12.2 additional days. (It should be noted that Class 3 Misdemeanor Offenses are not subject to consecutive sentencing.)


IV. IMPOSITION OF INTERMEDIATE PUNISHMENTS

This section provides a summary of the type of Intermediate Punishment imposed. *It only indicates offenders who received an Intermediate Punishment*. Intermediate Punishments include Special Probation (SP), Intensive Motivational Program of Alternative Correctional Treatment (IMPACT), Intensive Supervision Probation (ISP), Electronic House Arrest (EHA), Residential Treatment Facility (RESFAC), Day Reporting Center (DAY), or Community Penalties Program (COMMPN). See *Appendix C* for a brief description of each type of Intermediate Punishment.

Data indicate that 2,804 offenders received an Intermediate Punishment during the first six months of Structured Sentencing. However, the types of Intermediate Punishments were specified for only 483 offenders. The following tables reflect total Intermediate Punishments imposed rather than the total number of offenders receiving Intermediate Punishments.⁴ However, this limitation should have minimal impact on the data as only 22 offenders received more than one type of Intermediate Punishment during this period.

A. Type of Intermediate Punishment Imposed

Figure H displays the number of offenders receiving each type of Intermediate Punishment. Data show that where a specific type of Intermediate Punishment was indicated, Special Probation was the frequently most invoked punishment.



B. Type of Intermediate Punishment by Offense Class

Table 9 shows the frequency of Intermediate Punishments by Offense Class. Also shown are Tables 9a and 9b which display the frequency of Intermediate Punishments by Offense Class for sentences of 90 or less and sentences greater than 90 days, respectively. These tables reflect the frequencies of those Intermediate Punishments that were specified in the database.

Regardless of sentence length, the greatest number of Intermediate Punishments were imposed for Class 1 misdemeanors. For all Misdemeanor Offense Classes, Special Probation was the most frequently imposed type of Intermediate Punishment.

C. Type of Intermediate Punishment by Offense Class and Prior Conviction Level

Table 10 displays the frequency of Intermediate Punishments by Offense Class and Prior Conviction Level. The frequency of Intermediate Punishments by Offense Class and Prior Conviction Level for sentences of 90 days or less and sentences greater than 90 days are shown in *Tables 10a* and *10b*, respectively. These tables reflect the frequencies of those Intermediate Punishments that were specified in the database.

Table 10 indicates that, for all misdemeanors, Intermediate Punishments were most frequently imposed on offenders convicted of a Class 1 Misdemeanor Offense and classified in Prior Conviction Level II. Least likely to receive an Intermediate Punishment were offenders convicted of a Class 3 Misdemeanor Offense and classified in Prior Conviction Level III.

Considering offenders receiving a sentence of 90 days or less, Intermediate Punishments were most frequently imposed on offenders convicted of a Class 1 Misdemeanor Offense and having a Prior Conviction Level II. Least likely to receive an Intermediate Punishment were offenders who were convicted of a Class 3 Misdemeanor Offense and having a Prior Conviction Level III (see *Table 10a*).

Considering offenders who received a sentence greater than 90 days, Intermediate Punishments were most frequently imposed on offenders convicted of a Class 1 Misdemeanor Offense and having a Prior Conviction Level III (see *Table 10b*).

D. Type of Intermediate Punishments by Crime Category

Table 11 shows the frequency of Intermediate Punishments by crime categories. In addition to displaying the frequency of Intermediate Punishments by crime categories, *Tables 11a* and *11b* also consider length of sentence imposed. These tables reflect the frequencies of those Intermediate Punishments that were specified in the database.

Regardless of sentence length, Intermediate Punishments were most frequently imposed for Misdemeanor Public Order Offenses and least likely to be imposed for Misdemeanor Drug Offenses.

E. Special Probation

Table 12 shows the average length and number of Special Probation sentences by Misdemeanor Offense Class and location (jail or prison). Tables 12a and 12b display this information for sentences of 90 days or less and for sentences greater than 90 days, respectively.

Where a specific Intermediate Punishment was indicated, about 75% of misdemeanor offenders received Special Probation as a sentence. Offense Class 1 had the greatest number of offenders receiving Special Probation. Data indicate that the lower the Misdemeanor Offense Class, the shorter the average length of Special Probation sentences. (See *Table 12*).

Table 13 displays the number of Special Probation sentences by crime type and location. Of the four types of crime, Public Order Offenses accounted for the greatest number of offenders receiving Special Probation. Conversely, Drug Offenses accounted for the least number of offenders receiving Special Probation.

Table 13 also shows the average length of Special Probation sentences by crime type and location. Overall, offenders convicted of Public Order Offenses and Person Offenses received the longest average sentences (9.8 days and 9.5 days, respectively).

V. COMMUNITY SERVICE

A. Community Service by Offense Class

Data for the first six months of 1995 indicate that about 9% of all offenders received community service as a sentence. *Table 14* displays the average community service hours ordered by Misdemeanor Offense Class as well as the total number of offenders sentenced to community service by Offense Class. *Tables 14a* and *14b* show this information for sentences of 90 days or less and for sentences greater than 90 days, respectively.

For all misdemeanors, offenders convicted of a Class 1 Misdemeanor Offense were most frequently sentenced to community service and received the most community service hours, on average (see *Table 14*).

For offenders receiving sentences of 90 days or less, community service was most frequently ordered for offenders convicted of a Class 1 Misdemeanor Offense. These offenders also received the most community service hours, on average (see *Table 14a*).

Table 14b indicates that offenders receiving sentences greater than 90 days were most likely to be sentenced to community service if they had been convicted of a Class 1 Misdemeanor Offense. However, offenders convicted of a Class 2 Offense received the most community service hours, on average.

B. Community Service by Crime Type

Table 15 shows the average community service hours ordered by crime type and the total number of offenders sentenced to community service by Offense Class. Tables 15a and 15b show this information for sentences of 90 days or less and for sentences greater than 90 days, respectively.

For all misdemeanors, offenders convicted of a Property Offense most frequently received community service as a sentence. However, offenders convicted of a Person Offense were ordered to serve the most community service hours, on average (see *Table 15*).

For offenders receiving sentences of 90 days or less, those convicted of a Property Offense most frequently received community service as a sentence. The most community service hours, on average, were ordered for offenders convicted of a Person Offense (see *Table 15a*).

Table 15b shows that for offenders receiving sentences greater than 90 days, those convicted of Public Order Offenses most frequently received community service as a sentence. However, offenders convicted of a Property Offense were ordered to serve the most community service hours, on average.



APPENDIX C

INTERMEDIATE PUNISHMENTS

An intermediate punishment requires a sentence of supervised probation with at least one of the following conditions:

- 1. Split Sentence/Special Probation: Requires the offender to submit to a specified period of imprisonment in a prison or jail (total imprisonment may not exceed 25% of maximum sentence or 6 months, whichever is less) followed by a term of probation. It may include special conditions such as recommendation for work release or serving the active term in an inpatient facility. The IMPACT program (boot camp) is a form of special probation.
- 2. **Residential Facility:** Requires the offender to reside in a facility for a specified continuous period of time in order to participate in activities such as substance abuse counseling, social skills training, or employment training, conducted at the residence or at other specified locations.
- 3. Day Reporting Center: Requires mandatory attendance at a facility on a daily or otherwise regular basis at specified times for a specific length of time in order to participate in activities such as substance abuse counseling, social skills training, or employment training.
- 4. Intensive Supervision Probation: Requires close supervision by a probation officer in order to control and assist the offender to remain in the community pursuant to a community penalties plan, community work plan, community restitution plan, or other plan of rehabilitation.
- 5. Electronic Monitoring: Requires the offender to remain in one or more specified places for a specified period or periods each day to wear a device which permits the supervising agency to monitor the offender's compliance with the conditions electronically.
- 6. Community Penalties Plan Accepted by the Sentencing Judge: Requires the offender to comply with conditions specified in the plan.

COMMUNITY PUNISHMENTS

A community punishment is any authorized sentence that does not include an active punishment or an intermediate punishment. Community punishments can include, but are not limited to, one of the following: unsupervised or supervised probation (basic supervision not intensive supervision probation), outpatient drug/alcohol treatment, community service, restitution, fines, T.A.S.C. (Treatment Alternatives to Street Crime).

Endnotes

1. The number of convictions decreased during the month of June due to a week long Judges conference held that month.

2. Coding errors in reporting racial composition may account for the unusually large percentage of "Unknown" offenders.

3. The reader should note that this is only an estimate of the number of offenders that *may be* located in prison or jail (based on sentence length). Data on the actual placement of offenders was unavailable.

4. Intermediate Punishments have not always been reported. In some cases, the court may not have specified a specific type of Intermediate Punishments. It is likely, however, that the type of Intermediate Punishment imposed by the court has not been entered into the AOC Criminal Information System. Efforts are currently underway to determine the source of this problem and to take corrective action.
