CCIS-CC is a subsystem of the Court Information System tailored for Clerks of Superior Court. This web-based application extends, and will ultimately replace, the Automated Criminal/Infractions System (ACIS). As replacement components with enhanced capability are built in CCIS-CC, those components are retired in ACIS. This incremental approach in which smaller subprojects are identified, developed, and completed provides for faster delivery of improvements to the clerks.

The major components of CCIS-CC and ACIS are:

- The Criminal Component allows criminal case data to be entered from case initiating documents, e.g., warrants for arrest, orders for arrest, magistrate orders, or received electronically from NCAWARE or eCitation. Cases are tracked from initiation through disposition. Widespread inquiry access is available to court officials, law enforcement, and others. Trial court data is kept as cases move through district and superior court. More case information is available online in the Data and Information section of www.NCcourts.org.
- The Infractions Component allows infraction case data to be entered from case initiating documents (e.g., citations and criminal summonses) and updated as needed, or received electronically from eCitation. Cases are tracked from initiation through disposition. Inquiry access is available to court officials, law enforcement, and others, and cases are tracked through both district and superior court.

In both the criminal and infractions components, demographic data may be prefilled via a link with the N.C. Division of Motor Vehicles driver's license database.

Saves Time

- Preloads cases from calendars
- Reduces clerks' manual processes
- Consolidates multiple functions on a single screen to allow for speedy data entry
- Allows simultaneous processing of infraction and criminal cases for both superior and district courts on a single screen
- Processes large volumes of data in an efficient manner
- Allows reports to be viewed online or printed on demand
- Presents information in an efficiently structured manner

- Includes defaults, lookups, and drop-down features that reduce data entry errors
- Preloads data to reduce data entry errors
