INTRODUCTION

Pursuant to North Carolina Rule of Civil Procedure 37, Plaintiffs move to compel a response to their Second Set of Interrogatories. Plaintiffs' Second Set of Interrogatories requests basic information—the names and “home addresses” of incumbent legislators at the time of the creation of the challenged plans. Plaintiffs served Interrogatories seeking this information on January 16, but Legislative Defendants have refused to provide it. In their responses, Legislative Defendants instead directed Plaintiffs to a public website that listed “Preferred Mailing Addresses” for the relevant incumbents, which include P.O. Boxes for many incumbents. Plaintiffs endeavored to resolve this deficiency without court intervention. But at the meet and confer, Legislative Defendants offered shifting explanations for their refusal to respond to the interrogatories, suggesting that they do not understand the phrase “home addresses” to mean home addresses instead of P.O. boxes, and then stating that they would need to “look into” and “check on how much work that would be” to provide actual home addresses. It was clear that Legislative Defendants' counsel had not made any attempt to obtain this information from their clients before filing the interrogatory responses. Since the meet and confer, Legislative Defendants have not provided any date by which they will provide this basic information.

The incumbents' home addresses are critical for Plaintiffs' experts, for purposes of evaluating whether a hypothetical effort to avoid pairing incumbents could explain the challenged plans. Given the impending deadlines for Plaintiffs' expert reports (on March 22), Plaintiffs request that the Court order Legislative Defendants to respond to this motion by February 26 and to provide the home addresses by March 1. If Legislative Defendants do not provide this information by March 1, Legislative Defendants should be prohibited from offering any evidence or argument that any aspect of the 2017 Plans can be explained by an effort to protect incumbents.

BACKGROUND

On January 16, 2019, Plaintiffs Common Cause, the North Carolina Democratic Party, and 38 individual North Carolina voters served their Second Set of Interrogatories on Legislative Defendants.¹ See Ex. A. Interrogatory #1 asked Legislative Defendants to:

- “Identify the names and *home addresses* of each incumbent in the General Assembly at the time of the creation of the 2011 Plans in 2011.” Ex. A at 4.

Ex. A at 4 (emphasis added). This information is relevant because some of the districts in the 2017 Plans have remained unchanged since 2011.

Interrogatory #2 asked for the same information for the 2017 redistricting:

- “Identify the names and *home addresses* of each incumbent in the General Assembly at the time of the creation of the 2017 Plans in 2017.”

Id. (emphasis added)

Plaintiffs sought legislators’ “home addresses” because one of the adopted criteria for the 2017 Plans was to avoid pairing incumbent legislators into the same district. Plaintiffs anticipate that Legislative Defendants may contend that incumbency protection rather than partisan gerrymandering explains the contours of the 2017 Plans. Plaintiffs thus need incumbents’ home addresses at the time of each redistricting for, among other things, their experts’ analyses.

Legislative Defendants responded to the Interrogatories on the due date, February 15, 2019. They did not provide legislators’ home addresses, as requested. Instead, in their answer to Interrogatory #2, Legislative Defendants provided a link to a document on the General Assembly’s website that shows the “Preferred *Mailing Address*” of each member of the state House for the 2017-2018 Session. Ex. B (emphasis added). For many members, the Preferred Mailing Address is a P.O. Box, not their home address. In their answer to Interrogatory #1,

Legislative Defendants provided a link to an analogous page for the state House members during the 2011-2012 Session. Ex. C. For many members, the document indicates with asterisks that the address listed is the “Preferred Mailing Address” rather than their home address. *See id.*

Legislative Defendants provided no addresses at all for members of the state Senate, even though both Interrogatories requested the home address of “each incumbent in the General Assembly.” Ex. A. at 4. Plaintiffs nonetheless found webpages on the General Assembly’s website providing addresses for Senators. Like the webpages to which Legislative Defendants provided links for the House, these webpages similarly list the “Preferred Mailing Address” rather than the home address for Senators. Exs. D, E.

Immediately after Legislative Defendants provided their responses, on February 15, Plaintiffs emailed Legislative Defendants noting that the linked documents had P.O. Boxes for many members rather than home addresses. Ex. F (2/15/19 e-mail from Jones to Strach). At a meet and confer on February 18, Legislative Defendants asserted that their responses were responsive. After Plaintiffs explained that the interrogatories asked for home addresses, counsel for Legislative Defendants stated that he had not even *asked* his clients for this information: “I have to think through and look at what kind of effort it would take to go around and ask people.” In other words, by February 18—three days after responses were due—counsel had not made even a basic effort to obtain the relevant home addresses. Counsel said he would “have to check how much work that would be.” Plaintiffs emphasized the time-sensitivity of the requests given that Plaintiffs’ expert reports are due March 22. Plaintiffs further noted that, if the mapmakers had in fact considered incumbency protection in drawing districts in 2011 and 2017, Legislative Defendants must have provided the mapmakers with the incumbents’ home addresses, and

therefore must possess these records. Legislative Defendants promised to e-mail Plaintiffs by close of business on February 18 with an update.

Legislative Defendants did not do so. Instead, on February 19, Legislative Defendants e-mailed Plaintiffs asserting that Legislative Defendants had “provided exactly what was requested” in the Interrogatories. Ex. F (2/19/19 e-mail from Strach to Jones). Legislative Defendants falsely asserted that the webpages to which they had linked use the words “home address” to describe the addresses listed. *Id.* In fact, the webpages list the “Preferred Mailing Address” for all members in the 2017-2018 Session, and for many members in the 2011-2012 Session. Legislative Defendants nonetheless insisted that Plaintiffs’ “inartfully worded interrogatory” had caused “confusion,” and “[h]ad [Plaintiffs] wanted the physical address for mapping purposes, then that is what you should have written in the interrogatory.” *Id.* Legislative Defendants asserted that they would look to see if they had the 2011 and 2017 incumbents’ actual home addresses, and they would let Plaintiffs know by Wednesday, February 20, if they could find that information. *Id.*

Plaintiffs responded, noting that the phrase “home address” means the place where someone lives, not a P.O. Box or other address where the person receives mail. Ex. F (2/19/19 e-mail from Jones to Strach). Plaintiffs advised Legislative Defendants that they would move to compel unless Legislative Defendants provided the requested information by February 20. *Id.*

Despite committing to provide Plaintiffs an update by February 20, Legislative Defendants did not do so. They have provided no further information as of this filing. Plaintiffs’ expert reports are due March 22 under the stipulated case schedule.

ARGUMENT

North Carolina Rule of Civil Procedure 37 provides that a party may move to compel where another party “fails to answer an interrogatory submitted under Rule 33.” N.C. R. C.P. 37(a)(2). For purposes of a motion to compel, an “evasive or incomplete answer is to be treated as a failure to answer” a discovery request. N.C. R. C.P. 37(a)(3).

Rule 37 provides trial courts “the means and power to compel recalcitrant parties to abide by the rules of discovery.” *F. E. Davis Plumbing Co. v. Ingleside W. Assocs.*, 37 N.C. App. 149, 153, 245 S.E.2d 555, 557 (1978). “The party resisting discovery bears the burden of showing why the motion to compel should not be granted.” *Window World of Baton Rouge, LLC v. Window World, Inc.*, 2018 WL 6722590, at *2 (N.C. Sup. Ct. Dec. 19, 2018) (internal quotation marks omitted). “Specifically, the party seeking protection from the court from responding to discovery must make a particularized showing of why discovery should be denied, and conclusory or generalized statements fail to satisfy this burden as a matter of law.” *Nat’l Fin. Partners Corp. v. Ray*, 2014 WL 5148197, at *9 (N.C. Sup. Ct. Oct. 13, 2014) (internal quotation marks omitted). Legislative Defendants cannot meet their burden here to justify their refusal to provide the basic information—home addresses of incumbent legislators—sought in Plaintiffs’ Second Set of Interrogatories.

I. Legislative Defendants Must Provide the Information Requested in the Second Set of Interrogatories

Plaintiffs’ Second Set of Interrogatories is straightforward: it seeks the “the names and home addresses of each incumbent in the General Assembly at the time of the creation of” the 2011 and 2017 Plans. Ex. A at 4. There is nothing ambiguous about this request. A home address is the “the address of the house or apartment you live in.” Cambridge Dictionary, <https://tinyurl.com/y37vc5u9> (defining “home address”). And Legislative Defendants

necessarily provided the home addresses of incumbents to their mapmakers in drawing the 2011 and 2017 Plans. This is basic, highly relevant information that is obviously in the possession of Legislative Defendants.

Legislative Defendants have failed to answer these simple Interrogatories within the meaning of the North Carolina Rules because their February 15 responses were facially deficient and incomplete. What is more, they admitted on the February 18 meet and confer that they had not even begun searching for the incumbents' home addresses. They still have not provided any timeline by which they will produce the requested home addresses. Legislative Defendants are simply ignoring their discovery obligations under the North Carolina Rule of Civil Procedure.

Legislative Defendants' justification for their delinquent responses lacks merit and is not credible. Legislative Defendants stated that they thought the phrase "home address" in the interrogatory meant P.O. Box because, they contended, the webpages they provided listing incumbent legislators' P.O. Boxes or mailing addresses used the phrase "home address." Ex. F (2/19/19 e-mail from Strach to Jones). But a home address is a plain English phrase, it means the address where a person lives, and a person does not live at a P.O. Box. Even if the websites *had* erroneously referred to P.O. boxes as home addresses (and they do not), that would not excuse Legislative Defendants from providing actual home addresses, as the Interrogatories request. Plaintiffs did not reference these websites in their interrogatories.

In any event, the websites do not, in fact, refer to P.O. boxes as "home addresses." The webpage that Legislative Defendants provided for the 2017 incumbents list their "Preferred Mailing Address" and does not say "home address" anywhere. Ex. B. And the webpage for the 2011 incumbents indicates in bold asterisks that certain incumbents were publicly providing their "Preferred Mailing Address" *rather than* a home address, which in many instances was a P.O.

Box. Ex. C. In other words, the webpage makes clear that it did it *not* contain home addresses for many incumbents. Plaintiffs did not request incumbents’ “Preferred Mailing Address.”

The home addresses sought through the Second Set of Interrogatories are particularly important to Plaintiffs’ experts. There are 170 legislators and it is computationally complex and time-consuming to run computer analyses to consider how any hypothetical effort to avoid pairing incumbents might have affected the 2017 Plans. Legislative Defendants have delayed providing this basic information to gain a tactical advantage.

Legislative Defendants implied in their February 19 e-mail that they might only provide this information if the home addresses were “compiled into one place/document.” Ex. F (2/19/19 e-mail from Strach to Jones). Whether or not such a pre-compiled document exists—and Legislative Defendants have missed the February 20 deadline by which they promised to advise whether that document exists—Legislative Defendants still have to answer the interrogatories by providing home addresses. This information is in their possession and their obligation is to provide it whether or not the addresses were previously “compiled into one place.”

Plaintiffs therefore respectfully request that the Court order Legislative Defendants to provide the requested home addresses by no later than March 1.

II. In the Alternative, or if Legislative Defendants Do Not Provide The Home Addresses By March 1, the Court Should Bar Legislative Defendants From Defending the 2017 Plans on the Basis of Any Incumbency Theory

This Court “has broad discretion in imposing sanctions to compel discovery under Rule 37,” *F. E. Davis*, 37 N.C. App. at 153, 245 S.E.2d at 557, as well as “inherent authority to impose sanctions for discovery abuses beyond those enumerated in Rule 37,” *Cloer v. Smith*, 132 N.C. App. 569, 573, 512 S.E.2d 779, 782 (1999). As an additional or alternative remedy for Legislative Defendants’ failure to provide the home addresses sought, this Court should order

that, if Legislative Defendants do not provide the home addresses by March 1, they may not rely on any incumbent protection criterion in defending the challenged plans.

Plaintiffs anticipate that Legislative Defendants may try to argue that the contours of the 2017 Plans could be explained by an effort to protect incumbents, rather than partisan gerrymandering. To be clear, such an argument lacks merit. But to respond to this argument, Plaintiffs need the actual home addresses of the incumbents. Those are the addresses that are relevant to any incumbency-protection effort. If Legislative Defendants intend to rely on incumbency, they must provide Plaintiffs the information to assess that defense sufficiently in advance of the deadline for Plaintiffs' expert reports. If they do not, the Court should bar Legislative Defendants from invoking incumbency in any way in defense of the maps.

There is nothing unfair about such a remedy. After all, if Legislative Defendants are unable to provide information about the home addresses of incumbent legislators to Plaintiffs, as a factual matter, they could not have considered incumbency in drawing the maps.

III. The Court Should Award Fees and Expenses and Other Appropriate Relief

Rule 37(a)(4) provides that, where a motion to compel is granted, “the court shall, after opportunity for hearing, require the party or deponent whose conduct necessitated the motion . . . to pay to the moving party the reasonable expenses incurred in obtaining the order, including attorney’s fees, unless the court finds that the opposition to the motion was substantially justified or that other circumstances make an award of expenses unjust.” Thus, an award of fees and expenses is “mandatory” upon granting a motion to compel, *Graham v. Rogers*, 121 N.C. App. 460, 463, 466 S.E.2d 290, 293 (1996), unless the party that resisted discovery can show its opposition was “substantially justified” or awarding fees and expenses would otherwise be

unjust. “[T]he burden of proving the non-compliance was justified” rests with the party compelled to produce discovery. *Graham*, 121 N.C. App. at 4635, 466 S.E.2d at 294.

Legislative Defendants cannot meet their burden to show that their failure to produce responsive information “substantially justified.” The home addresses that Plaintiffs seek are basic information that is in the possession of Legislative Defendants and that they necessarily provided to their mapmakers when drawing the 2011 and 2017 Plans. Legislative Defendants made no effort to find this information during the 30 days between their receipt of the interrogatories and the deadline for their answer. The answers are now overdue. Legislative Defendants’ purported “confusion” about the meaning of the phrase “home address” is not credible, and even if it were, a week has now passed since Plaintiffs dispelled any conceivable confusion and Legislative Defendants still have not provided the information or even a timetable by which they will provide this overdue information. *See* Ex. F (2/15/19 e-mail from Jones to Strach). An award of fees and expenses for the time spent preparing this motion is warranted.

CONCLUSION

WHEREFORE, Plaintiffs request that the Court grant this motion and order Legislative Defendants to promptly provide full responses to Second Set of Interrogatories, including incumbent legislators’ home addresses, by March 1, and award Plaintiffs fees and expenses. The matters raised in this motion are time sensitive given the March 22 deadline for Plaintiffs’ expert reports, and Plaintiffs therefore request that the Court order Legislative Defendants to respond to this motion by February 26, 2019. Plaintiffs certify that they met and conferred in good faith with Legislative Defendants on the issues raised in this motion in an attempt to secure the information without court action.



**LEGISLATIVE DEFENDANTS' OBJECTIONS AND RESPONSES

Defendants Representative David R. Lewis, Senator Ralph E. Hise, Jr., Speaker of the North Carolina House Timothy K. Moore, and President Pro Tempore of the North Carolina Senate, Philip E. Berger (“Defendants”) by and through undersigned counsel, serve their objections and responses to Plaintiffs’ Second Set of Interrogatories as follows:

GENERAL OBJECTIONS

Defendants make the following answers, responses, and objections to Plaintiffs’ Second Set of Interrogatories (“Interrogatories”). Each of the following responses is made subject to any and all objections as to competence, relevance, or other grounds that would require exclusion of such statement if made by a witness present and testifying in court. Any and all such objections and grounds are expressly reserved and may be interposed at the time of the trial.

The responses are based on Defendants’ present knowledge, information, and belief, as derived from: (a) the knowledge and information of present employees or agents of Defendants

gained in their capacity as such, and (b) a review of the documents and materials maintained by Defendants that would be likely to contain the information called for by the Interrogatories. These responses are subject to amendment and supplementation as Defendants acquire additional information and complete their review and analysis and made without prejudice to Defendants' right to use subsequently discovered or developed information. Defendants state that their responses to the Interrogatories were prepared in consultation with their attorneys and may not exactly match the words or phrases that may be used by individuals in the course of this litigation to describe events, policies, and practices discussed herein.

No incidental or implied admissions are intended by these responses. The fact that Defendants respond or object to any Interrogatory should not be taken as an admission that Defendants accept or admit the existence of any facts assumed by such Interrogatory or that such Response or objection constitutes admissible evidence as to any such assumed facts. The fact that Defendants respond to part of or all of any Interrogatory is not intended to be, and shall not be, construed as a waiver by Defendants of any part of any objection to any Interrogatory.

Defendants will respond to Plaintiffs' Document requests in accordance with Rules 26 and 33 of the North Carolina Rules of Civil Procedure and will not provide responses or documents to the extent such responses or production would exceed the requirements of those Rules.

Since the North Carolina Rules of Civil Procedure prohibit discovery of privileged matters, Defendants have attempted to interpret each Document Request to call for discoverable matter only. To the extent any response or produced document contains or refers to matters otherwise protected from discovery by the work product doctrine, the attorney-client privilege, or the legislative privilege, no waiver is intended; nor is any waiver intended as to any other matters that are or may be subject to such protection or otherwise privileged.

These responses are provided solely for the purpose of and in relation to this action.



physical address for mapping purposes, then that is what you should have written in the interrogatory. This is now the second time an inartfully worded interrogatory by the plaintiffs has caused confusion.

In any event, after our call from yesterday, I now understand that you believe/assume the physical addresses of the legislators in 2011 would have been compiled into one place/document and used by staff in drawing the map and that we should use that information to answer the interrogatory. I don't know if such a compilation/document exists, but we are actively inquiring about it and will let you know tomorrow what we find. If we find such a compilation/document, we will supplement the interrogatory response with any new information, if any, it contains.

As you know, our interrogatory explicitly and unequivocally asked for the members' "home addresses" and not any P.O. Box, because a member's home address is of course the key address for purposes of redistricting.

Given that this is another instance in which legislative defendants have failed to provide basic information by the deadline required by the rules -- and given the approaching deadline for our expert reports -- please confirm tonight that you will provide complete responses listing each member's actual home address by close of business on Tuesday, February 19.
