Barbara Pugh after being duly sworn does allege and say as follows:

- 1. Barbara Clark Pugh is a Plaintiff here in her individual capacity and in the capacity as President of the Winnie Davis Chapter #259.
- 2. Barbara Clark Pugh is a citizen and resident of Chatham County, North Carolina.
- 3. The Winnie Davis Chapter #259 is a not for profit association and a constituent member of the United Daughters of the Confederacy, North Carolina Division, Inc.
- 4. The Winnie Davis Chapter #259 was formed on November 5, 1898 as a constitutent member of the United Daughters of the Confederacy and was authorized to perform all acts pertaining to the purposes of the United Daughters of the Confederacy, and to enact for its own government, such By-Laws as they deem necessary.
- 5. The Winnie Davis Chapter #259 was initially formed with twelve members.
- 6. The Winnie Davis Chapter #259 has been active and in full force and effect from its formation to the present and at no time has the Winnie Davis Chapter #259 had fewer than seven active members.
- 7. Barbara Clark Pugh has been a member of the Winnie Davis Chapter #259 since 2002 and has served as president since 2008.
- 8. In 1899 the Winnie Davis Chapter #259 began work memorializing the Confederate dead by placing a tombstone at the head of deceased ex-Confederates. This practice continuous to the present time.
- 9. In 1901 the Winnie Davis Chapter #259 delivered 50 "Crosses of Honor" to Confederate veterans. This was the first of a total of 217 "Crosses of Honor" so delivered.
- 10. A generation later, the descendants of 12 Confederate veterans were presented with a "Cross of Military Service."
- 11. In August 1907, the Confederate Monument on the Courthouse Square was a gift to the County of Chatham by the Winnie Davis Chapter #259 as a memorial to the the Confederate veterans, living and dead.
- 12. In 1922, the Winnie Davis Chapter #259 placed a large marble marker in the local high school, bearing the names World War I veterans who had gone to school in Pittsboro, North Carolina.
- 13. The Winnie Davis Chapter #259 has supported the "Soldiers Home" in Raleigh,

North Carolina and the Confederates Women's Home in Fayetteville, NC.

14. The Winnie Davis Chapter #259 maintains a "Confederate Bookshelf" in the public library.

- 15. The Winnie Davis Chapter #259 has accepted the beautification of the Jefferson Davis Highway as it passes through Pittsboro, NC.
- 16. It is the founding and current purpose of the Winnie Davis Chapter #259 to honor and memorialize those who have fought in wars.
- 17. The Winnie Davis Chapter #259 continues to be active to accomplish this purpose.
- 18. The Winnie Davis Chapter #259 filed an Assumed Business Name Certificate on May 8, 2019 in Book 2043, Page 959, Chatham County Register of Deeds. A copy of this document is attached hereto and incorporated herein by reference. This Assumed Business Name Certificate was executed and filed in error.
- 19. The Winnie Davis Chapter #259 executed and filed an Amendment of Assumed Business Name Certificate on May 26, 2019 in Book 2080, Page 154, Chatham County Register of Deeds. The effect of the Amendment is to replace the name of the erroneous real party in interest with the correct real party in interest. A copy of this Amendment of Assumed Business Name Certificate is attached hereto and incorporated herein by reference.
