## \*\*\*PLEASE NOTE THE FOLLOWING CHANGES\*\*\*

- 1. Effective January 1, 2019, each week of Civil Court in Courtroom 3H will have both a Motions AND Jury Calendars. There will no longer be a weeklong Motion session.
