MODIFICATION OF
INTERIM ORDERS ON BOND
RELEASE CONDITIONS


THIS MATTER COMING ON TO BE HEARD by the undersigned and it appearing to this Court that the State, represented by Alex Bass and the Defendant, represented by Mr. Jason L. Keith, have reached an agreement regarding the bond conditions in this case, this Court makes the following Finding of Fact:


1. On October 31, 2020 the Defendants with others attended a protest in downtown Graham, North Carolina.
2. The Defendants listed above were arrested and charged with a misdemeanor offense.
3. The Defendants were given a pre-trial release condition, "Do not come back into the city limits of Graham, North Carolina for 72 hours after their arrest."
4. Defendant's have constitutional rights to vote and need to enter Graham city limits to vote.
5. The State and Defendant consent to striking the language that restricts entry into the city limits. The parties hereby agree to modify the language to say that, "The Defendant shall not be within 100 yards (300 feet) of the Alamance County Historic Courthouse on November 3, 2020."

BASED UPON THE FOREGOING AND THE CONSENT OF THE PARTIES it is hereby ORDERED:


1. The bond condition restricting entry into Graham city limits is hereby MODIFIED as follows: That the Defendant agrees not to be within 100 yards (300 feet) of the Alamance County Historic Courthouse on November 3, 2020. This order is to be effective immediately.



