

ASSESSMENTS AND DATA-DRIVEN STRATEGY

- Conduct **county-specific assessments** to identify strengths, gaps, and needs in human trafficking enforcement and create a baseline for measurement.
- Track and analyze arrest, investigation, and prosecution data over time to monitor enforcement trends, measure improvements, and tailor ongoing training and support accordingly.

RECURRING \$500,000 in Direct Service Grants (state funds)

Nine awards made for FY 2024-2025. All in close out or closed.

Committee voted on awards for 2025-2027 but those are holding until we confirm the state budget allows us to use the funds.

Grant Program Updates:

Of the roughly \$22.9 million kept with us from the federal appropriation:

- There were roughly 110 agencies and over 180 grantee contracts.
- To date, we have spent / issued out a total of just under 90% of the funds.
- Many grantees are still incurring expenses and have revisions to expenditure reports due.
- The funds must be expended by the end of December 31, 2026. We are on track for all agencies to be spent out by June 30, 2026.

Grant Program Updates

Roughly 40 contracts are closed out with an estimated 20 more in closing status.

Still holding 8 positions for the management of these funds.

We are being refunded years 2 and 3 of the contract from the grants management system we initially began working with. All grantees are currently using the SmartSheet system.
