Q&A Session with Tyler Technologies

Patrick Slaughter, Director of Professional Services for Tyler Technologies, demonstrated Guide & File, the pro se platform of the Judicial Branch's new statewide electronic-filing and case-management system, and answered questions about the product.

Plan for Report to Joint Legislative Oversight Committee on Justice and Public Safety

The North Carolina Administrative Office of the Courts will provide a report no later than March 1, 2020, to the Joint Legislative Oversight Committee on Justice and Public Safety, as mandated by North Carolina Session Law 2019-243 (House Bill 470), Part 1, Section 3.(b). Andrew Simpson stated that the report will cover the Commission's progress toward providing proposed rule amendments to the Supreme Court of North Carolina.

General Rules of Practice Subcommittee Report

Mark Anderson, Subcommittee Chair, reported that additional edits have been made to the preliminary draft of a revised Rule 5, "Form of Pleadings."

Discussion ensued as to whether the rule should make it mandatory for all attorneys to e-file their documents with the court. Possible exceptions were also debated.

Discussion ensued concerning the time of filing—specifically, whether deadlines should be enforced at 5:00 p.m. or 11:59 p.m. Consensus was reached that the subcommittee should draft a rule with a 5:00 p.m. deadline.
