

Addressing #SaveOurChildren, Explaining Child Sex Trafficking

In the past several weeks, child sex trafficking has become a hot topic on social media and online forums leading to an increase in public concern about the issue. Common posts and discussions include but are not limited to viral stories about complex human trafficking operations involving well known political figures, celebrities and retailers.

Polaris is deeply concerned that these unproven online stories have had a negative impact on the work of fighting trafficking and keeping children safe being undertaken every day by trusted organizations, service providers, governments and law enforcement agencies.

Contact information for the National Human Trafficking Hotline is public and sharing it does not imply affiliation: The National Trafficking Hotline (Trafficking Hotline) is operated by

Polaris, a nonprofit organization. Polaris does not approve the posting or sharing of information about how to contact the Trafficking Hotline. In other words, just because the Trafficking Hotline information appears on a social media post, a poster, or anywhere else, does not imply affiliation with or approval by the Trafficking Hotline, or by Polaris.

- **Sample Facebook/Instagram Post:** The National Human Trafficking Hotline is operated by Polaris. The Trafficking Hotline's contact information is public, and the appearance of the Trafficking Hotline's information anywhere does not imply affiliation with or approval by the Trafficking Hotline, or Polaris, a nonprofit that operates the Trafficking Hotline.
- **Twitter:** The National Human Trafficking Hotline's contact info is public. If the Trafficking Hotline's info appears anywhere, it does not imply affiliation with or approval by the Trafficking Hotline, or by Polaris, the nonprofit that operates the Hotline..

The National Human Trafficking Hotline takes every contact seriously: The Trafficking Hotline connects victims and survivors to help and support around the country. This could mean assistance finding a safe place to stay, a ride, or a trauma counselor or attorney, for example. The Trafficking Hotline also takes reports from members of the public who believe they may have firsthand or unique information about a trafficking situation. Every tip shared with the Trafficking Hotline is taken seriously and acted upon accordingly. The Trafficking Hotline does not investigate tips and cannot verify the accuracy of information shared with us. The role of the Trafficking Hotline is to provide a single point of entry for those seeking assistance and to share information and reports, as necessary and appropriate, with partner organizations including law enforcement in some cases.

- **Sample Facebook/Instagram Post:** The National Human Trafficking Hotline connects victims and survivors to help and takes tips about potential trafficking situations. The Hotline doesn't investigate tips. The Hotline shares the information with appropriate investigative agencies as warranted. All reports are taken seriously and handled with care. That's why we ask the public to think carefully about whether they have firsthand or unique information to share.
- **Twitter:** The Trafficking Hotline takes tips about potential trafficking & connects victims and survivors with help. The Hotline doesn't investigate tips. The tips that really help are from people with firsthand knowledge of a situation.

Abduction or kidnapping into sex trafficking situations are extremely rare: Children virtually always know and trust the person who trafficks them. Most commonly, children are trafficked by members of their own families, or by people they have developed relationships with, online or in person, and believe to be their friends, romantic partners or benefactors.

Not all missing children are sex trafficking victims, but runaway children are at greater risk than other children for sex and labor trafficking: Statistics and data about missing children in particular should not be confused as the number of children being victimized in sex trafficking situations.

- **Sample Facebook/Instagram Post:** Not all missing children are sex trafficking victims, but runaway children are at greater risk than other children for sex and labor trafficking. In 2018, an estimated 1 out of 7 endangered runaways reported to the National Center for Missing and Exploited Children were likely child sex trafficking victims. What You Should Do

Call the Trafficking Hotline if you have firsthand information beyond what is publicly available: If you have actual personal knowledge of a situation or individual that concerns you that is not publicly available through other sources, the Trafficking Hotline can help ensure that information is acted upon as quickly and effectively as possible. Please be mindful that a flood of secondhand information may lead to longer wait times for victims and survivors who need immediate assistance for their own safety.

- **Sample Facebook/Instagram Post:** Call the National Human Trafficking Hotline if you have any firsthand knowledge about a situation of trafficking that is not publicly available through other sources. A flood of reports with secondhand information may lead to longer wait times for victims and survivors in need of immediate assistance.

- **Twitter:** Call the Trafficking Hotline if you have info about a trafficking situation not publicly available through other sources. A flood of secondhand reports leads to longer wait times for victims & survivors in need of immediate help.

Consider the source of information you receive: Child sex trafficking is real and there are many organizations and government agencies who have been working to fight it for years.
