Dear Court Officials:

Please see the failure to appear (FTA) and failure to comply (FTC) processing tables immediately below. These are the same versions of these tables that we shared with you on June 30, and that we referenced again on July 29.

The emergency directives from the Chief Justice that affected FTAs and FTCs expired this past Friday, July 31.

This means that

 the window within which a person could "undo" certain previously-entered FTAs and FTCs has expired (see the second row of the FTA table and the second row of the FTC table),

\*\*\*

- clerks now will process the backlog of certain FTCs that have been stayed since April 6 (see the third row of the FTC table), and
- clerks will assess the FTA and FTC fees, and make the FTA and FTC system entries and reports to DMV, for any new FTAs and FTCs occurring from this point forward pursuant to the usual practice.

Dear Court Officials:

As you know from the email notice that the NCAOC Communications Office sent shortly before noon, Chief Justice Beasley today entered an order extending Emergency Directives 2 through 8. A copy of this order is available <u>here</u>.

If you have had an opportunity to review the order, you may have noticed that the content of Emergency Directive 7 in today's order is identical to the content of Emergency Directive 7 as it appeared in the Chief Justice's June 29 order. So, there is <u>no change</u> to the FTC processing table as it appears immediately below in the email of June 30. The Chief Justice included Emergency Directive 7 in today's order just to confirm that it extends through July 31. Today's order does <u>not</u> extend Emergency Directive 7 beyond July 31.

So, again, nothing in today's order changes the FTA and FTC processing tables that appear immediately below in the email of June 30. The information in the June 30 FTA and FTC tables below remains accurate.

On Monday evening, 29 June 2020, Chief Justice Beasley entered an order that, among other actions, modifies Emergency Directive 7 regarding the payment of monies in criminal and infraction cases. The full order is available <u>here</u>.

This latest modification of Emergency Directive 7 requires the NCAOC Office of General Counsel (OGC) to update the failure to comply processing table that it previously provided to you. The failure to appear and failure to comply tables appear immediately below, with the latest changes highlighted. The failure to appear table is unchanged.

Subject: FTA and FTC processing guidance / 21 May 2020 order

Dear Court Officials:

Set out in the emails below from 4 May 2020 and 14 April 2020 is the previous guidance we have provided on failure to appear (FTA) and failure to comply (FTC) processing in light of prior orders of the Chief Justice.

Yesterday's order of the Chief Justice further extended the deadlines for filings and acts in criminal and infraction cases, and it requires that we update our FTA and FTC processing guidance.

Specifically, in her order of 21 May 2020, the Chief Justice directed that, in criminal actions, "[a]Il deadlines for filing documents and papers and all deadlines for other acts that were due to be filed or done between 16 March 2020 and 31 July 2020, inclusive of those dates, are hereby extended until the close of business on 31 July 2020."

(<u>Note</u>: The order provides that this updated criminal case extension language does *not* alter the 1 May 2020 directive regarding criminal monies owed or the 13 April 2020 directive regarding bond forfeitures. I addressed criminal monies owed in a separate email earlier this morning. Troy Page will address bond forfeitures in a future email as the relevant deadlines draw nearer.)

Dear Clerks:

I am writing on behalf of the Office of General Counsel to provide a further update on failure to appear (FTA) and failure to comply (FTC) processing in light of the order entered by Chief Justice Beasley this past Friday, 1 May 2020.

Friday's order extends the FTC delay period (i.e., the period during which clerks will delay the entry of the FTC, the assessment of the FTC fee, and the report of the FTC to DMV) through 30 May 2020.

Specifically, the order contains the following provision: "The clerks of superior court also are directed not to enter or report, until after the expiration of this order, a failure to comply for a criminal or infraction case with a payment due date before 6 April 2020 where the 40th day following nonpayment falls on or after 6 April 2020 and before or on 30 May 2020."

This language, which originally appeared in Chief Justice Beasley's 2 April 2020 order, previously set an end date of 1 May 2020. The updated order from this past Friday extends the end date to 30 May 2020.

Just as with the 2 April 2020 order, this FTC exception does *not* apply to "[m]onetary obligations owed pursuant to a term of probation which is scheduled to end within 30 days after the date that this order is issued."

	<u>Note</u> : Under the Chief Justice's 2 April 2020 order, this delay does <u>not</u> apply to a defendant who is on probation and whose period of probation is scheduled to expire on or after 3 April 2020 and before or on 2 May 2020. Under the Chief Justice's 1 May 2020 order, this delay also does <u>not</u> apply to a defendant who is on probation and whose period of probation is scheduled to expire on or after 2 May 2020 and before or on 31 May 2020.

<u>Note</u>: You may recall that in her 2 April 2020 order, the Chief Justice delayed certain payment due dates by 90 days. The Chief Justice continued and extended this directive in her 1 May 2020 order. The Office of General Counsel will address this in a separate email notice.

Subject: update on FTA and FTC processing / 13 April 2020 order

Dear Clerks:

I am writing to provide updated guidance on the processing of failures to appear (FTA) and failures to comply (FTC) in light of the updated extension order entered by the Chief Justice on 13 April 2020.

This order changes the extension period end date from 17 April 2020 to 1 June 2020.

You previously received the following two emails from me:

- an email dated 24 March 2020 addressing FTA and FTC processing in light of the extension order entered by Chief Justice Beasley on 19 March 2020 ("RE: FTA and FTC processing," 03/24/2020 at 10:06 AM), and
- an email dated 3 April 2020 addressing payment due dates and FTCs in light of the criminal monies owed emergency directive entered by Chief Justice Beasley on 2 April 2020 ("RE: criminal monies owed / 2 April 2020 emergency directive," 04/03/2020 at 5:59 PM).

Based on the updated extension order entered yesterday by the Chief Justice moving the extension period end date from April 17 to June 1, the NCAOC Office of General Counsel (OGC) is updating its prior guidance on FTA and FTC processing in order to reflect the new extension period end date:

### 1. failures to appear

FTA accrual date (i.e., the 20 <sup>th</sup> day after the failure to appear) falls before 16 March 2020	Process the FTA as normal
FTA accrual date (i.e., the 20 <sup>th</sup> day after the failure to appear) falls on or after 16 March 2020, and before or on <mark>1 June 2020</mark>	Process the FTA as normal, <u>but</u> the defendant later may "undo" the FTA by obtaining a new court date or disposing of the offense before the close of business on <mark>1 June 2020</mark> .
(This category is governed by the Chief Justice's orders of 19 March 2020 and 13 April 2020.)	If the defendant "undoes" the FTA by obtaining a new court date or disposing of the offense before the close of business on <mark>1 June 2020</mark> , then the clerk will remove or refund the FTA fee, and report to DMV that the FTA was "entered in error" so that DMV will remove the FTA from its records.

the end of May.)	<u>Note</u> : This delay does <u>not</u> apply to a defendant who is on probation and whose period of probation is scheduled to expire on or after 3 April 2020 and before or on 2 May 2020.

<u>Note</u>: You may recall that in her 2 April 2020 order, the Chief Justice also delayed certain payment due dates by 90 days. That directive remains in effect, and was not altered by the order the Chief Justice entered yesterday.
