**\*\*\* PLEASE NOTE THE FOLLOWING CHANGES\*\*\***

1. Pursuant to Rule 6(d) of Rules of Civil Procedure, “notice of hearing for motions must be served no later than 5 days before the time specified for the hearing”. Therefore, the deadline for submitting your calendar request to the TCC will be 5pm on the Monday prior to your requested hearing date (TCC must physically have calendar request by deadline).
2. Pursuant to rule 5(a1) of Rules of Civil Procedure, all briefs and/or memoranda in support or opposition of motions must be submitted to the TCC 2 business days prior to the set hearing date.
