Contracts update

- □16.20A Grant agreement is finalized.
 - □11 agencies have been sent grant agreements
 - ☐ 6 agencies have been signed by all parties
 - ☐ 1 agency is working on original revisions
 - □ 3 agencies are waiting for legal questions
- □ 16.20B Grant agreement is being drafted by legal for contracts.
 - ☐ 1 agency to be voted on today

16.20 Disbursement List

- Sent to finance 6/2/23 to draw down funds
 - ■* this is only 1 step of the process
- disbursement payment, which were requested Friday. Whether or not all 6 get their 1st payment in June is dependent on OSC setting up new people in the accounting system.



16.20B: Another Technical Correction:

TECHNICAL CORRECTIONS TO GRANTS TO DEVELOP, STRENGTHEN, OR EXPAND HUMAN TRAFFICKING VICTIM SERVICE PROGRAMS

SECTION #.(a) Section 16.20B.(a) of S.L. 2021-180, as modified by Section 5.2.(b) of S.L. 2023-11, reads as rewritten:

"SECTION 16.20B.(a) Of the funds appropriated in this act from the State Fiscal Recovery Fund to the Administrative Office of the Courts, Human Trafficking Commission (Commission), the sum of one million one hundred forty thousand dollars (\$1,140,000) in nonrecurring funds for the 2021-2022 fiscal year shall be used to develop, strengthen, or expand human trafficking victim service programs. These funds shall be allocated as follows:

- (1) Two hundred fifty Five hundred thousand dollars (\$500,000250,000) to Compassion to Act Incorporated, a nonprofit corporation.
- (2) Three hundred twenty Six hundred forty thousand dollars (\$640,000320,000) to the North Carolina Institute Against Human Trafficking.

SECTION #.(b) This section is effective when this act becomes law

16.20 Next Steps

- Getting all contracts executed
- Continuing to issue the first quarterly payments to any newly executed agreements
- Sending these agencies the internal controls list and beginning risk assessment process
- Sending out Quarterly Report packets and due dates

- Quarterly Reports update

38 have reports for quarters 1 -3 approved.

A handful have spent all of their funds.

We are having trouble receiving original corrections from 6 agencies and are investigating one of those due to being placed on the SOFL.

Extensions

We have received confirmation that a one-year extension will be granted.

Legal will advise us about how / when to get those signed.

14 agencies have requested an extension and we will try to have those ready for signing, when legal gives the green light.

- First Disbursement List totaling \$3,059,763.92 paid out on 5/23/23
- Second Disbursement List has 20 awards totaling \$820,000 was requested Friday.
- □The next list for draw down and eventual disbursement will be for those with a Period of Performance (POP) beginning on 7/1/2023. This has been created.
 - □ Once finance gives the green light to submit next FY, we are ready!

☐ From the original agency list of 88 DV/SA agencies, there are a handful of applications that are either not ready for vote at this time or we are waiting on small questions before the contract is signed.
