

# Grants Management Updates 16.20 – Jacqueline's updates

#### WILL NOT APPLY FOR FUNDING (5)

- Abolition NC Education and Training agency Disqualified
- •Safe Place (Mitchell County) Will not apply for this funding.
- Onslow County Partnership for Children Declined due to staffing changes.
- World Relief Corporation of National Association of Evangelicals No longer have a human trafficking program.
- Ministry Seven Declined as they do not accept federal, state, or local government funding.

#### Agency/Project Impact

#### 16.20A RFP

These activities are not allowable costs for awarded funding, even for agencies that provide direct services to victims.



### 1. Haven House

1. Support costs to hire a consultant- review/improve current workflows, identify or develop a new screening tool, work with us to develop an evaluation plan (Case management service for victim services)

### 2. Changing Destinies

1. We don't foresee opening up our long term facility until next Apr, 2024. With renovation, we also have training and hiring, etc. to do. But we are considering another plan for a short term safe house. Someone has offered their home as a possibility. However, strategic planning isn't until the end of April, 2023. We probably wouldn't see women coming therfore at least 6 more months if everything lined up perfectly. You know how that goes. (Not ready, ask them to apply and submit as how they plan to provide direct services, connect with a survivor)

### 3. LilyPad Haven/Hope for Justice

1. We appreciate you and the committee taking time to review our application. As I have shared in previous emails, Hope for Justice merged with Lily Pad Haven and the dissolution process of Lilypad Haven began last year on March 31, 2022. We would be happy to provide documentation of both the merger and the pending dissolution of Lily Pad Haven, Inc. (Table for next meeting)

### 1. Christian Recovery Center

The first initiative, building a Resource Center, is at the core of the entire proposal. Building design, engineering and bidding has begun. A preliminary drawing is attached (no attachment received yet). Site preparation begins in May and Construction is scheduled to start on August 01, 2023. It will be fully furnished, equipped and occupied with class start up by March 31, 2024. Also on August 01, renovation of a transitional housing facility will begin with housing planned to be available by October 01. (Table for next meeting)
