SECTION 16.21 Competitive grants for nonprofit organizations providing services to victims of human trafficking

Total of \$3,800,000 to be disbursed to applicants whom satisfy requirements:

- Be a nonprofit corporation.
- Be providing direct services to victims of human trafficking, which may include case management, client safety, client well-being, and other services, including health, transportation, housing, education, and employment assistance.
- □ Be ineligible for a grant under the provisions of G.S. 50B-9 and G.S. 143B-394.21.

There were a number of <u>required</u> attachments for applications. These were to assist in the pre-award risk assessment and the scoring of the applications.

Risk Assessment	20 points
Standards Self-Assessment	10 points
