# Section 16.20 Grants for Nonprofit Organizations Providing Services to Victims of Human Trafficking

#### 16.20

- □ A total of \$ 1,924,699.32 has been disbursed for Section 16.20
  - □ 16.20A \$ 1,639,791.82
  - □ 16.20B \$ 284,907.50
- □ All **17** agencies have submitted quarterly financial and progress report packets have been received and processed by grant staff.
- 5 site visits have been conducted to date



### SECTION 16.23 Economic Assistance Funds for Organizations that Provide Services to Victims of Domestic Violence and Sexual Assault

#### 16.23

- □ Total payments disbursed: \$7,446,314.52
  - □ DV \$3,782,134.62
  - □ SA \$3,664,179.90
- □141 total awards have gone out for disbursement.
- 67 awards for Sexual Assault/74 Domestic Violence
- Report packages are being reviewed



- RFP:
  - ☐ Released August 11, 2023
  - ☐ Closed September 11, 2023
- ☐ Grant capped amounts:
  - ☐ Minimum \$50,000
  - Maximum \$200,000
- Applicants applied for either a one-year or two-year grant cycle.

- 24 Applications were received
- 4 applications did not move on to scoring for various issues:
  - Ineligible
  - No SAMS # provided by extension deadline
  - Nonprofit status
  - Withdrawal

Round 1- Enhance services to victims of human trafficking.

- 20 Applications were scored by8 people.
  - One reviewer decline to score an application, citing a conflict of interest for the record.

- ■11 Awards were approved on November 20, 2023.
- \$2,006,246.00 awarded in round 1 leaving \$1,793,754.00 available for round 2.
- ☐ The committee has adopted a baseline score of **51** and above out of **100** points to be considered for funding.

#### Round 1

- 8 individualized meetings were held with agencies that did not receive funding in round 1 to proactively provide feedback and strategies on improvement.
   All Contracts were entered into DocuSign on December 4, 2024
   Period of Performance began on January 1, 2024 and will extend to one or two.
- □ Period of Performance began on January 1, 2024 and will extend to one or two years.
- ☐ All Reporting packages went out on **February 6, 2024**
- □ Reporting webinar is set for later this afternoon **February 22, 2024** and tomorrow **February 23, 2024**.
- ☐ The first disbursement went out on February 13, 2024 and February 14, 2024 for 10 of the 11 agencies totaling \$335,518.89.
  - ☐ One agency was not entered into the accounting system initially which resulted in a delay.
- ☐ Monitoring plan to satisfy NCPRO requirements has been completed.



- Round 2: Developing, strengthening, or expanding human trafficking victim service programs to help mitigate the increased risk of human trafficking
- ☐ Grant award minimum and maximum amounts remain the same as in round 1.

- ☐ Grant Manager held informational webinar with 50 attendees from 35 agencies and has fielded numerous calls / emails.
- ☐ Round 2 RFP was Released January 8, 2024 and will close on March 8, 2024.
- □ Round 2 will remain open for 60 days.

### General Assembly Reports Due

16.20 – Due March 1, 2024 16.21 – Due March 1, 2024

Both are routing for approval now for submission.

SB105 requires reporting on 16.20 and 16.21 on or before September 1 and March 1 of 2022 and 2023.

- (1) The number of applications received.
- (2) The number of grants awarded.
- (3) The names and locations of the grant recipients.
- (4) The amount of each grant awarded.
- (5) A description of the human trafficking program initiatives that were funded by the grant awarded, including the geographic area in which services were provided.
- (6) The total number of victims of human trafficking that were served, to date, by each grant recipient.
