Section 16.22 Facility Improvement Grants

- Round 1 All grant agreements have been signed; AOC Finance and Budget Management are working on final steps to release funds.
- Round 2 RFP issued on August 10th, 2022, proposals were due by September 30th, 2022.
- To Domestic Violence and Sexual Assault agencies found eligible through the NCCWYI.
- 61 applications received, 8 of those new applicants. The amounts varied from \$6K to \$200K for a total of over \$4 million.
- Committee voted to award 61 of these for a total of \$2,075,586.00 with a 51.2777% reduction.
- Adjustment notices will be sent to all applicants requesting budget adjustment to reflect reduction.

Section 16.23 Economic Assistance Funds for Organizations that Provide Services to Victims of Domestic Violence and Sexual Assault

- The sum of fifteen million dollars (\$15,000,000) in nonrecurring funds shall be used to reduce the negative economic impact of the COVID-19 pandemic on organizations that provide domestic violence and sexual assault services across the State
 - HTC is holding 10% of this funding back for admin cost.
- Economic Assistance Funds can be applied as early as July 1, 2021. Grant contract end is being suggested as June 30, 2024.
- RFP released on Wednesday October 26th and applications are due via email by Wednesday November 30th at 5:00pm.

Section 16.23 Economic **Assistance Funds** for Organizations that Provide Services to Victims of Domestic Violence and Sexual Assault

- 88 Domestic Violence and Sexual Assault agencies identified as eligible through the NCCWYI.
- Formulas for agency applications:
 - 17 Stand Alone Domestic Violence Agencies
 - \$86,540 per agency
 - 61 Dual DV/SA agencies can also apply for this
 - 61 Dual DV/SA Agencies
 - \$71,930 per agency
 - 10 Stand Alone Sexual Assault Agencies
 - \$236,250 per agency
- Organizations that are determined eligible as providing both domestic violence services and as a dual domestic violence/sexual assault agency per the NCCWYI, must submit two separate applications.

- Agencies in this section will be considered beneficiaries instead of subrecipients.
- Asking for Federal Funding Accountability and Transparency Act (FFATA) Certification Form and a Conflict of Interest form that mirrors federal standards.
- We have built in post award controls to help with monitoring, such as planning quarterly payments, but also creating a form for requesting additional payments.
- Grants Management System is still a possibility but waiting the quote from DOT.
