

NC Human Trafficking Commission: Legislative Committee Meeting January 21, 2021 WebEx through the NC Judicial Center

Welcome & Introductions 10:00am

Committee Chair Caitlin Brooks opened the meeting and conducted a verbal roll call to document attendance. Committee members in attendance at the meeting were Daniel Bowes, Caitlin Brooks, Sarah Byrne, Tarrah Callahan, Danielle Carman, Jennifer Haigwood, Tammy Harris, and Eric Zogry. Also in attendance was Commission Staff, Christine Long.

Approval of Minutes: 11.5.2020

No amendments to the minutes were requested and the minutes passed unanimously.

Marriage Age Law Presentation

Laura Puryear, McGuireWoods Laura Puryear presented on a recent study in North Carolina around underage marriages. McQuireWoods Consulting will proceed with a legislative proposal to restrict such marriages. Please see materials for power point details.

Potential Legislative Items

Committee Chair Brooks reviewed where the committee is with drafting a bill to close a loophole discovered in non-DSS involved custody transfers. Commissioner Carman and Committee Chair Brooks will examine recent feedback gained from other agencies and revise the draft for the committee to review again.

Committee members Sarah Byrne and Daniel Bowes discussed the list introduced in the previous meeting for more discussion. Items discussed were:

- 1. Amend N.C.G.S. 14-43.13 or create new statute to accomplish statutory goal of criminalizing buyer conduct: Sarah and Daniel consulted with some state assistant district attorneys and the feedback was positive. A simple add of the term "patronizes" to the statute would suffice for current goals and the committee will table seeking to increase the penalty for buyers.
- 2. Increased access to post-conviction relief by modifying the HT-specific relief statutes to no longer require victim testimony. Sarah reports that a recent case went through without a victim testifying and believes this can be tabled for now as well.
- 3. Daniel brought up the potential need to examine making testifying easier, for changes to 14.204 for conditional discharges, and to add a recommended assessment going to victims to be paid prior to fees and fines being taken out. The Committee will note these for consideration at another point.
