## BIOGRAPHY

### **Maggie Brewer**

Deputy Director, NCDPS / ACJJ / Community Corrections

Maggie began her career with the North Carolina Department of Public Safety (formerly NC Department of Correction) in November 1996.

She started at Central Prison as a Case Manager working directly with offenders. She also worked in the Diagnostic Center at Polk Youth Institution (now known as Granville CI) prior to her transfer to Community Corrections. In December of 1998, Maggie was promoted to Probation and Parole Officer in Wake County. She worked her way up through the ranks as a Chief Probation and Parole Officer, Judicial District Manager for Wake County and in April 2014, she was named the Assistant Division Administrator for Division II. In this role, she oversaw operations for twenty-one counties and assisted managers with day-to-day decisions that impacted their respective counties.

Since August 2018, she has served as Deputy Director for Community Corrections overseeing the operations of program administration throughout the section.

Throughout her career, Maggie has served on the Community Corrections Emergency Response Team. She has been a certified training instructor since 2001 and specializes in firearms. She served as the Vice Chair of the Sex Offender Management Committee in 2006. This committee guided the implementation of the Static-99 assessment and Satellite Based Monitoring in North Carolina. In 2007, she was elected President of the North Carolina Probation and Parole Association (NCPA) and in 2008, she was the recipient of the NCPA President's Award. She continues to remain active in the association and currently serves as Historian.

Maggie graduated from North Carolina State University with a Bachelor of Arts degree in Political Science and Criminal Justice. She is a graduate of the NC Department of Public Safety Correctional Leadership Development Program (CLDP). Maggie has worked as a group project liaison with past and current CLDP participants since graduating from the program.
