## Important Notes

The purpose of this directory is to provide a centralized resource for agencies and groups working to combat human trafficking across the state. The NC Human Trafficking Commission (NC HTC) has not vetted the organizations or persons listed in this directory. Do not construe placement on this directory as an endorsement or recommendation.

We encourage all users to research and assess each entity by reviewing agency websites, learning agency mission and values, asking questions about policies, procedures, political or religious affiliations, and previewing admission paperwork or client agreements before determining appropriate fit for referrals. The NC Secretary of State website is also a resource to search for information on a business or charity, including charitable solicitation license status.

❖ **To search the document for services or location, we recommend using control + find (ctrl + f)**

❖ **Consistent Terminology**

- **Emergency shelter beds:** provide 24/7 emergency shelter. To be included in this section, the agency should provide shelter admissions to its target population 24/7, with low barrier requirements. For example, if the program has an application process that has to be sent prior to admission, then it would not be considered an emergency shelter.
- **Housing:** Refers to non-emergency shelter, including long-term or transitional shelter

❖ **Variable Terminology**

Organizations have self-identified the services they provide, and therefore, some of the terminology may vary across organizations. We recommend searching for all related terms to see all services available. For example:

- Therapy and counseling are used interchangeably, and the specific term used depends on each organization
- Substance Abuse/Rehabilitation/Use

❖ **The Tier Ratings in this directory match the Polaris Project:**

- **Tier 1:** The agency's primary focus and/or mission is human trafficking
- **Tier 2:** Human trafficking is part of their focus, but they also focus on other populations, AND they have a specific human trafficking project/staff
- **Tier 3:** The agency's focus and mission is not focused specifically on human trafficking, and has no specific human trafficking staff or project
- **Tier 4:** general social services, accept referrals or attend trainings, etc. on trafficking

❖ **Definitions in footnotes come from the Regional Response Team (RRT) and Task Force Local Collaboration Enhancement toolkit created in partnership with NCCAHT.**

Definitions are not meant to limit or pigeon-hole local efforts but rather facilitate cooperation and maximize efficiency when connections need to be made quickly, and to provide shared definitions and uniform language.

## 5. North Carolina Department of Public Safety (NC DPS)

**Background/Mission:** Safeguard the lives/property of people in NC

**Direct Service Provider:** No

**Duties/Responsibilities:**

- **NC Alcohol Law Enforcement (ALE)** is working to train alcohol distributors across the state on what to look for with human trafficking. ALE investigates violations and enforces all criminal laws occurring on any of the over 19,000 ABC permitted businesses. This includes investigating human trafficking allegations as well as other crimes. ALE Special Agents train alcohol industry members on how to identify human trafficking victims and ways to report suspected violations. Special Agents also ensure the Human Trafficking Hotline poster is prominently displayed at each of these businesses.

- **Reentry, Programs and Services** is studying the scope of this problem among women entering prison. The project will now end 12/31/2020 and the deliverables will be a tool to identify HT victims during diagnostic admissions to prison, to identify programmatic needs to address HT induced trauma, and specific training for custody staff to better identify HT related behaviors.

## 7. NC Department of Labor

**Background/Mission:** Foster a safe, healthy, fair, and productive North Carolina

**Direct Service Provider:** No

**Duties/Responsibilities:**

- Administers and enforces the Occupational Safety and Health Act which sets forth safety and health requirements for most private and public sector workplaces; conducts compliance inspections; provides education and training on OSHA standards to employers and employees
- Administers and enforces the Migrant Housing Act which sets forth requirements for migrant housing; annually inspects migrant housing prior to occupancy
- Administers and enforces the Wage and Hour Act which includes coverage for minimum wage, overtime, youth employment, wage payment, etc.; accepts and investigates employee complaints

Each year, SAF trains approximately 25 students on farmworker issues, and places them to work full-time with migrant education programs, legal aid offices, rural health clinics, community-based organizations and farmworker unions. SAF interns increase the capacity of the organizations they work with by outreaching to over 5,000 farmworkers & their families each summer.
2. Levante Leadership Institute: SAF's Levante Leadership Institute is a program designed to increase educational success and develop social skills of Latino youth from farmworker families in Johnston County and the surrounding area. Through popular education and cultural arts such as documentary/theater, students share their experiences, build confidence, gain leadership skills, and explore options for higher education. We connect youth families with community resources and engage them in SAF's advocacy and organizing work.
3. Solidaridad internship: Solidaridad is an academic year internship for college students, recent graduates, or Dreamers in the North Carolina Triangle area. Participants work in SAF's office and receive mentorship and training. They are part of a cohort and together they learn about the farmworker justice movement and gain nonprofit leadership skills. Interns support SAF's mission by conducting presentations, mentoring farmworker youth, creating communication tools, and participating in actions, rallies, and coalition meetings.
4. From the Ground Up program: SAF educates and informs thousands of community members by raising awareness of injustices in the agricultural industry through our From the Ground Up program. We use presentations, documentary work, and actions to inform and mobilize students and community members around current legislation, consumer boycotts, and other justice efforts led by farmworkers. We coordinate National Farmworker Awareness Week to raise awareness about farmworkers on our campuses and in our communities.

### 3. **UNC-CH, Project No Rest**

**Description:** Project NO REST (North Carolina Organizing and Responding to the Exploitation and Sexual Trafficking of Children) began in 2014 as a 5-year initiative funded by the U.S. Children's Bureau to address the trafficking of youth age 25 and under in the state. The project is designed to increase awareness of human trafficking affecting children and youth, especially those involved in the child welfare system in North Carolina; to reduce the number of these youth who are trafficked; and to improve outcomes for those who are trafficked. The project addresses labor trafficking as well, and is designed to support and extend the state's infrastructure to fight trafficking.

With NC stakeholders, Project No Rest created a comprehensive plan to address the trafficking of youth in NC: <http://projectnorest.web.unc.edu/comprehensive-plan-2/> With additional funding from the state, 5 communities representing 17 counties from across the state were recruited to implement the plan at the local level. Project staff worked with the communities to support the development of collaborative networks to provide extensive workforce and community training and technical assistance. The pilot sites served more than 500 individuals who have been trafficked or were at risk of being trafficked. The experiences of these communities in implementing the plan are being used to develop a toolkit for other communities across the state and nation to use in implementing anti-trafficking efforts. The project also held two state-wide trafficking conferences.

The Victims of Crime Act grant also supported a statewide outreach campaign for trafficking victims and survivors that provided information on how to obtain help. As part of that campaign, close to 20,000 spots were aired on TV and radio stations across North Carolina.

Project NO REST developed an array of short videos that can be used in training. Several members of the Project NO REST team conducted training across the state for the child welfare supervisors. In early 2019, the curriculum was converted to an online effort that is available to child welfare social workers across the state. A separate curriculum for foster parents is available online.

In 2018, Project NO REST launched a demand reduction initiative “What’s at Stake” in Fayetteville, NC. The initiative partnered with a local service provider and used geofencing to send digital ads cell phones who were in certain areas between midnight and 5am. The ads described the consequences of purchasing sex and directed individuals to a website with further information. The ads had a very high click-through rate. A version of “What’s at Stake” is being implemented in Wake County in the fall of 2020.

Project NO REST was involved in an effort funded by the NC HTC in 2019 and 2020 to expand outreach to farmworkers at risk of labor trafficking, and to increase the timely response to the needs of victims/survivors by providing limited case management that connects survivors to integrated direct services and legal assistance. The project targeted H2-A visa holders, a population identified by the Polaris Project (2018) as workers highly vulnerable to labor abuse.

**Project Description:** The North Carolina Governor's Crime Commission project entitled *Building Capacity to Identify and Serve Human Trafficking Victims in Eastern NC* (funding cycle one: 10/01/2018-09/30/2020; funding cycle two: 10/01/2020 – 09/30/2022) is a partnership between the North Carolina Network for Safe Communities (NCNSC) at the University of North Carolina at Greensboro, North Carolina Stop Human Trafficking Now, Outer Banks Hotline, and Roanoke-Chowan S.A.F.E. The purpose of the project is to build capacity to identify and provide direct services to victims and survivors of human trafficking in traditionally undeserved geographic regions in Eastern North Carolina. The Outer Banks region consists of Camden, Currituck, Dare, and Pasquotank counties. The Roanoke-Chowan region consists of Bertie, Gates, Hertford, and Northampton counties. Capacity-building activities include region-wide training opportunities, educational and outreach events, and coordination of services.

Additionally, the partnership is working to create and maintain multidisciplinary collaboration, as well as measurement and tracking of outcomes. The first cycle of this grant also served Nash, Edgecombe, and Wilson Counties.

NCNSC is providing education related to human trafficking on college campuses and working with statewide partners to implement human trafficking reduction strategies and educational and awareness efforts. NCNSC continues to present locally and nationally.

Most recently the team has presented at the Institute on Violence, Abuse, and Trauma's Summit in September 2020 about human trafficking on college campuses. NCNSC has partnered with the NC Council for Women and Youth Involvement with support from the NC Department of Public Instruction to work with local school

systems on implementing required human trafficking education to students and staff. NCNSC is assisting the National Criminal Justice Training Center (NCJTC) with a pilot program to virtually implement their Multi-Disciplinary Team Response to Child Sex Trafficking Training Program as the COVID pandemic has halted the ability of the NCJTC to continue with their programming in-person. NCNSC is currently working with the Labor Trafficking Task Force facilitated by World Relief Triad and is assisting with data collection efforts to better understand the labor trafficking dynamic associated with begging and sales crews locally.

Prior NCNSC work in the area of human trafficking has included a North Carolina Governor's Crime Commission funded project in partnership with the Dream Center of Fayetteville, NC (funding cycle: 7/01/2015-6/30/2016) with the goal of providing transitional housing to victims and survivors of human trafficking. NCNSC produced a detailed report highlighting lessons learned, along with challenges/barriers and opportunities, to increase identification and response to victims and survivors of human trafficking as well as approaches to deterring traffickers and reducing demand. Additionally, NCNSC partners with the United States Attorney's Offices in all three federal judicial districts in North Carolina (EDNC, MDNC, and WDNC) on initiatives involving Violent Crime Reduction and Project Safe Neighborhoods.
