UPGRADES MADE TO THE 2019-20 RENEWAL APPLICATION AND CME SELF REPORTING

NCDRC staff is excited to share with you upgrades that have been made to the FY 2019-20 Renewal Process. Mediators will now be able to self-report CME when completing their Renewal. Because of this change, staff will no longer be accepting the CME Self Reporting Form after May 31, 2019. Inactive mediators are not required to complete two hours of CME, however you must complete the renewal application and pay the fee(s).

For those of you that have already submitted CME for the upcoming renewal period, your information has been recorded and you will have full access to your renewal application on or after July 1, 2019. You will not be required to enter the CME course(s) you attended/watched this year.

Renewal instructions for mediators who have not submitted or completed CME:

After a mediator has completed two hours of CME, s/he will log in to their renewal application on or after July 1, 2019, complete their application and at the bottom of the form click on the CME course(s) they have taken. You must enter two or more hours of CME for the application to be accepted. Once the application is accepted, the mediator can then update their profile, pay the fees by credit card, or print out their invoice to mail in payment. You will not be able to submit your application until you have recorded two hours of CME.

If you still have not completed your two hours of required CME, please visit the Commission's **Current CME Opportu- nities page.**

Staff understands that the renewal process can sometimes be confusing, we hope these new changes will make the renewal process a quick and easy process. As a reminder, the upcoming renewal period runs from July 1 -September 30, 2019.

<u>DRC Lapsed and Restatement Policy</u> and <u>DRC Dated and Out-of-State Training Policy</u>. The Commission felt that there was inconsistent language in the Dated and Out-of-State Training Policy and the Lapsed Status and Reinstatement Policy. The Commission voted to align the policies so lapsed persons and persons with dated training had the same requirements to become certified/recertified.

FFS Rule 2 and **FFS Rule 8**. Consistency and Quality. To bring all those who mediate mandatory court ordered programs under the purview of the DRC, to ensure all mediators would be bound to same rules and standards. All mediators would have proper training, and be competent in the services they perform. Provide honor and integrity to the program, courts and the Commission.
