Trials

Trials will be set by the TCA's office each week. Attorneys and parties must follow the instructions provided in the heading of the most recently published court calendar. *Failure to appear for the calendar call may result in dismissal of the action and other sanctions by the court - simply reporting a case as settled to the TCA's office does NOT relieve an attorney of his/her ethical obligation to appear for the calendared trial or hearing, unless excused in advance by the TCA's office or by court order.*

Motions

Motions will be set by the TCA's office on each weekly session above, upon receipt of a completed calendar request and compliance with local rules and the most current court operations. *Calendar requests submitted for motions that have not yet been filed will be ignored.* Attorneys and parties must confirm the date and time of the motion setting from the published court calendar and notice their motions accordingly.

Calendar request deadline

Starting on 8/16/2021, calendar request forms must be received by the TCA's office at least one month prior to the session of court requested, except for minor settlements and motions for TROs.
