CALENDARING MOTIONS:

Calendar Requests (WAKE-CVS-01) may be submitted for **MOTIONS or TRIAL** sessions and should be sent to:

Motions On *MOTIONS* Calendar:

- Motions will be given a set date/time certain during the week
- Special scheduling requests must be provided on line #5 of the Calendar Request and are not guaranteed
- Settings are based upon the time estimate provided on the Calendar Request - motions will NOT be added after the calendar has been finalized

Motions On *TRIAL* Calendar:

- All parties & counsel must appear for the Calendar Call on the first day of the session to determine when the matter will be heard during the week
- Motions set on this calendar will NOT be given a set date/time prior to the calendar call

Add-On Motions (Requests to schedule motions after the Calendar Request Deadline has passed):

- Requesting party must verify the availability of all parties/counsel prior to submitting the Calendar Request
- The request will not be considered if boxes #3 and #4 of the Calendar Request form are blank
- Add-on motions will be given last priority on the calendars and will be heard only if court time allows
- Dispositive motions will NOT be added to the trial date; requests to do so may be made to the trial judge on the day of trial
