

## WAKE COUNTY COURTS OPERATIONS DURING COVID-19 RESTRICTIONS EFFECTIVE MARCH 13 – APRIL 17, 2020\*

Consistent with the directives of the Chief Justice of the North Carolina Supreme Court, effective Monday, March 16, superior court and district court proceedings in Wake County will be continued for at least 30 days, with limited exceptions. See below for detailed information.
