Unless excused in advance by the TCA's office or by court order, *simply reporting a case as settled to the TCA's office does not relieve an attorney of his/her ethical obligation to appear for the calendared trial or hearing.*

Trials

Trials will be set by the TCA's office every week on the trial calendar(s). Calendar call will take place on the first day of each weekly session at 10:00 a.m.

Motions

Upon receipt of a completed calendar request and compliance with local rules and procedures, motions will be set by the TCA's office on each weekly session in AM and PM settings on the motion calendar. The TCA's office has the discretion to set motions on trial calendars, as needed.

Remote Hearings

To join a Webex hearing, confirm the Webex Courtroom number (e.g., #1 or #2) from the Hearings tab of the case in [Portal](#) and select the corresponding link from our website, www.nccourts.gov/WakeTCA.

Calendar Requests

Calendar request forms must be submitted by email, calendarrequestswake@nccourts.org, or by fax (919) 792-4951.

Confirm Trial / Hearing Dates

Hearings are published no later than three weeks prior to the first day of the court session on [Portal](#). *Publication of the hearing to [Portal](#) shall serve as sufficient notification by the court that a case has been set (i.e., the calendar is considered published/final at this time and no changes will be made absent court order or approval by the Court Administrator).*

Judge Assignments

The judges assigned to each weekly session are available from the 2024 Master Calendar, which is published online by the NCAOC, [Superior Court Master Calendar | North Carolina Judicial Branch](#). These assignments are subject to change. Once confirmed, the name of the presiding judge will be made available on the hearings tab of the case in Portal.

NOTE: Hearings may be set by the Court Administrator on UNASSIGNED – HOLIDAY weeks, as needed. Attorneys and parties should not assume that court is closed during these weeks.
