Administrative Matters

A motion was made and approved to adopt the minutes from the May 20th Technology Committee meeting, as drafted and distributed.

Presentations

eCourts Strategic Plan Updates -

Andrew Flewelling and Doug Rowe of BerryDunn

BerryDunn is looking to hire a new subcontractor with substantive knowledge of eCourts and court operations. They are also adjusting their original approach to now focus on describing the current state of technology in the Judicial Branch, through information gathered from technology staff and users, and then, documenting the future vision of technology for the branch. They will conduct a gap analysis between those two areas, and they will still utilize an adapted maturity model.

By the end of June, they will deliver a portion of the strategic plan which outlines the current state and future vision of technology. In the next iteration, which is anticipated by early July, the details will include findings and results that have been identified through gap analysis. BerryDunn will define a set of initiatives, and these will be prioritized by the subcommittee of judicial officials from the Technology Committee.

One example of an initiative would be proposing the use of a centralized case management system and outlining options that exist for implementation. This led to a brief discussion about building the system "in-house" with NCAOC TSD staff or opportunities that might exist to acquire off-the-shelf systems from a vendor. Vendor based solutions would still require TSD staff to customize the tools to fully integrate with current Judicial Branch technology. BerryDunn recommended that an external contractor could be utilized to develop an RFP with the level of complexity needed to ensure existing data exchanges and information sharing with external agencies could be maintained.

Committee members reiterated their goal to implement technology statewide to ensure the public's experience is the same in all counties and meeting their expectations. It was pointed out that the current project to improve the nccourts.org website is an example of modernization with uniformity in mind.
