COURTS THAT HAVE SIGNIFICANTLY RESIGNED THEIR SERVICES

- States where significant work has been done:
 - Minnesota, Vermont, New Hampshire,
 Nebraska, Oregon, Maine, Michigan, Utah,
 Arizona, Iowa
- Trial courts where significant work has been done:
 - Wayne County, Flint, Michigan; Orange County, Sacramento, California

VALUES: MAINTAIN AND IMPROVE QUALITY WHILE.....

- 1. Improving **CONVENIENCE** to litigants
- 2. Reducing **COST** and **COMPLEXITY** to litigants
- 3. Improving ACCESS to justice for litigants
- 4. Improving case **PREDICTABILITY** for litigants

NEW HAMPSHIRE

- Unification of probate, family and district courts
- Restructure the management of the circuit court (implemented)
- Create a call center
- Abandon paper-bound processes in favor of digital

MINNESOTA

- Centralize payable processing (e-citations, call center, payment entry of receipts)
- E-courts
 - Traffic citations and electronic filing
 - Civil e-filing
 - Document scanning
- Centralize/regionalize jury management

UTAH

- E-everything
- Comprehensive clerical reorganization
- Centralized self-help center
- Performance management

VERMONT

- Integrate the probate court into the trial court and require probate judges to be lawyers
- Comparable pay and benefits and management of all court employees
- Reduce middle management
- Venue set by Vermont Supreme Court

SIX STRATEGIES TO INCREASE EFFICIENCY AND IMPROVE QUALITY

- 1. Automate appropriate functions to the maximum
- 2. Centralize processes
- 3. Regionalize processes
- 4. Standardize processes
- 5. Outsource processes
- 6. Systematically and aggressively apply case management

- Filing and docketing of documents and motions
- Payments
- Document access and retrieval
- Litigant self-help
- Notifications and service
- Creation of the official court record
- Archiving
- Jury services (partial)
- Provision of the record on appeal

CENTRALIZE PROCESSES

- Filing
- Payments
- Collections
- Document access
- Data queries
- Jury services (partial)
- Interpreters (partial)

REGIONALIZE SERVICES

Jury services (partial)
Videoconferencing

Expert witnesses
Interpreters
Hearing officers

STANDARDIZE SERVICES

- Every administrative process statewide?
- Disaggregate by size?
- All technology statewide?
 - External interfaces only?
 - Services only?
 - Applications, systems, infrastructure?

Electronic Payables (fines, fees, restitution, etc.)	Arraignments for incarcerated defendants	Statewide fines schedule	Consolidation of judicial districts	E-file with an electronic document management system
Automated referrals to collections	Detention hearings for detained juveniles	Expand the list of misdemeanors and ordinance violations that are fines only	Court consolidation— single tier trial court or single tier limited jurisdiction court	Electronic workflow
Traffic citations	Child support hearings	Courtroom docket entry into the case management system to prepare sentencing orders with electronic signatures (e.g., in court updating of files)	Review jurisdiction and venue as related to centralized, regionalized filing or cases and centralized issuance of orders	 E-filing Centralize/regionalize filing centers Self help software Electronic citation by all law enforcement
Call centers	Simple motions hearings	Digital recording of court proceedings	Expand use of subordinate judicial officers	Electronic signatures on orders, notices, etc.
