Motions On Motions Calendar:

- Motions will be given a set date/time certain during the week
- Special scheduling requests must be provided on line #5 of the Calendar Request and are not guaranteed
- Settings are based upon the time estimate provided on the Calendar Request; therefore, requests to add additional motions or change the scheduled date/time may not be possible

Motions On Trial Calendar:

- All parties & counsel must appear for the Calendar Call on the first day of the session and discuss scheduling with the presiding judge; motions set on this calendar will NOT be given a set date/time prior to the calendar call

Add-On Motions (Requests to schedule motions after the Calendar Request Deadline has passed):

- Requesting party must verify the availability of all parties/counsel prior to submission of the add-on request to the TCA's office; this must be indicated on the Calendar Request in check boxes #3 and #4 on the form or the request will not be honored
- Add-on motions will be given last priority on the calendars and will be heard only if court time allows
- Dispositive motions will NOT be added to the trial date; requests to do so may be made to the trial judge on the day of trial
