\*SEE NOTES BELOW\*

**On Motions Calendar:**

- Motions will be given a set date/time certain during the week
- The TCA may set motions on a trial calendar, in his/her discretion
- Special scheduling requests must be provided on line #5 of the Calendar Request and are not guaranteed
- Settings are based upon the time estimate provided on the Calendar Request; therefore, requests to add additional motions or change the scheduled date/time may not be possible

**On Trial Calendar:**

- Motions will NOT be given a date/certain during the week until after the Calendar Call
- All parties & counsel must appear for the Calendar Call on the first day of the session and discuss scheduling with the presiding judge

**Add-On Motions/Requests to schedule motions after the Calendar Request Deadline has passed:**

- Requesting party must verify the availability of all parties/counsel prior to submission of the add-on request to the TCA's office; this must be indicated on the Calendar Request at check boxes #3 and #4 on the form
- Add-on motions will be given last priority on the calendars and will be heard only if court time allows
- Dispositive motions will not be added to the trial date by the TCA's office; requests to do so shall be made to the trial judge at the calendar call
