<b>Child Support Enforcement Court (Courtroom 8110)</b>	<p>All actions for establishment or modification of child support brought by or through Mecklenburg County Child Support Enforcement (CSE) will be scheduled for a remote hearing.</p> <p>*CSE enforcement matters may be scheduled for in-person hearings on Mondays and Thursdays. Modification and establishment cases which cannot be held remotely may be scheduled for in-person hearings on the 1<sup>st</sup> and 3<sup>rd</sup> Tuesdays of each month.</p>

Victims and family members may participate in the remote first appearance hearings using the MeckWebA link.

Defendants who have been released from custody prior to the scheduled first appearance hearing do not need to appear in court or on Webex. Defense counsel will be assigned, and a court date will be communicated by mail and can be obtained by calling the Public Defender's Office or the Clerk of Superior Court's Office.

\*Non-domestic violence misdemeanor bond hearings will be held on Wednesdays during the afternoon session. Two bond hearing slots are available each Wednesday afternoon in courtrooms 4310 and 4150. Defense attorneys must request the bond hearing at least seventy-two (72) hours in advance.

\*Domestic violence misdemeanor bond hearings may be scheduled seventy-two (72) hours in advance by defense counsel. One bond hearing slot is allocated each morning in courtroom 4130.

\*Misdemeanor probation violations and probation violation probable cause hearings will be held during the Friday morning sessions of the court in which the judgment was entered. The non-domestic violence probation violation matters will be held on Friday mornings in courtrooms 4150 and 4310 during the month of March 2022. Domestic violence probation violation matters will be held on Friday mornings in courtroom 4130 during the month of March 2022.

\*Pretrial Readiness Conferences (PTRC) and Case Management Conferences (CMCR) will be held on Mondays during the afternoon session beginning at 1:30PM in courtrooms 4150 and 4310. Remote conferences will begin at 2:00PM via Webex.

<p><b>Criminal Superior Court (Courtroom 5110, 5310, 5350, 5370)</b></p>	<p>Criminal administrative court will operate in courtroom 5310. Arraignments will be held on Monday through Thursday beginning at 9:30 a.m. Administrative settings for homicide cases will continue to be heard on Thursdays during the felony crime and habitual felon team weeks. Bond hearings will be scheduled for Fridays. A limited number of cases will be scheduled in four (4) ninety-minute blocks each day. On Monday through Thursday, eight (8) cases will be scheduled per quad. On Fridays, six (6) cases will be scheduled per quad.</p> <p>*Probation matters will be held every other week in courtroom 5350. A limited number of cases will be scheduled in four (4) ninety-minute blocks on Monday through Thursday beginning at 9:30 a.m. Probation probable cause hearings will be held in the first quad on Monday. Eight (8) probation violation hearings will be held in the remaining quads on Mondays and all quads on Tuesday through Thursday.</p> <p>*Criminal trials will operate in courtrooms 5370 and 5110. Should the civil trial docket in courtroom 6130 conclude during a session of court, then that courtroom may be used for the trial of criminal cases if the necessary personnel are available to staff it and there are criminal cases on the criminal calendar to be resolved.</p>

<b>Jury Duty</b>	<p>All grand jury proceedings will continue as scheduled.</p> <p>Jurors summoned to appear should follow their reporting time and instructions listed on their jury summons.</p>
<b>Juvenile— A/N/D Court (Courtroom 8330, 8350, 8370, 8390)</b>	<p>All abuse neglect and dependency hearings, except for termination of parental rights, adjudication, and disposition hearings, will be scheduled for a remote hearing.</p> <p>Matters that cannot be heard remotely may be scheduled for the designated in-person hearing day for each geo-district.</p>
<b>Juvenile - Delinquency Court (Courtroom 8330, 8350, 8370, 8390)</b>	<p>Secure custody review hearings and first appearance hearings will be scheduled as remote hearings and should not be continued except for good cause.</p> <p>Return Indictment hearings for juveniles who are detained shall be scheduled for remote hearing and return indictment hearings for out-of-custody juveniles may be scheduled remotely in the discretion of the presiding judge.</p> <p>Juvenile delinquency adjudication, disposition and review hearings may be scheduled as remote hearings with the consent of the juvenile and parent(s)/guardian(s) provided on the record as a knowing and voluntary waiver of the right to be present for an in-person proceeding.</p> <p>Delinquency matters may be scheduled for in-person hearings on Mondays and Thursdays.</p>
<b>Recovery Court</b>	<p>*Recovery Courts will conduct hybrid court sessions every two weeks per the Recovery Courts calendar.</p>
<b>Small Claims Court (Courtroom 2310, 2330, 2350, 2370)</b>	<p>Small claims proceedings, including summary ejections and money owed cases, will be scheduled for in-person hearings. The numbers of cases scheduled per session will be capped to ensure adherence to courtroom occupancy.</p>
